 The Pineapple & Coconut Grove Association of the State of Florida do hereby certify that we have and do hereby subdivide All of Jupiter Island, said Island being situated in Townships Thirty-eight (38), Thirty-nine (39) and Forty (40) South of Ranges Forty-two (42) and Forty-three (43) East in the County of Dade and State of Florida; and have laid the same off into Lots Each of said Lots in Ten (10) chains wide north and south, excepting Lots Eighty-nine (89), Ninety-eight (98) and One hundred and three (103) which are fractional and all extend from the Atlantic Ocean on the east to the shore of Indian River on the west, excepting Lots 59, 60, 61, 62, 63, and 64, which extend to the shore of a bayou on the west; and excepting Lot 99, which is bounded on the east by the bayou, on the west by Indian River and on the North by Lot 65. Jupiter Island hereby subdivided is a part of the Eusibio M. Gomez Grant a Patent having been issued therefore by the President of the United States to the said Gomez, his heirs and assigns May 8<sup>th</sup> A.D. 1889.

This subdivision is made by virtue of a resolution of the Board of Directors and Stockholders of this Association passed November 9<sup>th</sup> A.D. 1885; the said Association being the owners thereof

The survey of the Lots commenced at a point due East of the center of the Lighthouse between Lots 100 and 101, in Township Forty (40) South of Range Forty-Three (43) East.
