

KNOW ALL MEN BY THESE PRESENTS that the Palm Beach County Land Company, a corporation created and organized under the laws of Florida, owns in fee simple Government Lots 2, 4, 5 and 6 of Section 17, (excepting certain town lots thereof heretofore conveyed by it) and the E. 1/2 of S.E. 1/4 of S.E. 1/4 of Section 18, in Township 38 South, Range 41 East, in Palm Beach County, Florida; that said land is shown on this map as the Amended Plat of Palm City, Florida; that the original Plat of Palm City was filed in the Clerks Office of Palm Beach County, Florida, on May 11, A.D. 1912, and recorded in Book 2 of Plats, page 24 of said County; that this Amended Plat of Palm City differs from the original Plat of Palm City aforesaid in that this Amended Plat includes Government Lot 4 of Section 17 and the E. 1/2 of S.E. 1/4 of S.E. 1/4 of Section 18, Township 38 South, Range 41 East; and in that Palmetto Place is shown on this Amended Plat as 30 feet wide instead of 20 feet wide, and the Lots in Block 2 are shown as 140 feet long instead of 150 feet long, as on the original Plat; that the said Palm Beach County Land Company dedicates to the Public for use as Public Highways all streets shown on this Plat, and it expressly reserves to itself and retains title to all said singular the riparian rights (except such Riparian rights as it has heretofore conveyed) appertaining to the entire tract of land above described.
