A PORTION OF THE NORTHEAST ONE-QUARTER (NE 1/4) OF THE SOUTHEAST ONE-QUARTER (SE 1/4) OF SECTION 5, TOWNSHIP 40 SOUTH, RANGE 38 EAST; AND A PORTION OF THE NORTHWEST ONE-QUARTER (NW 1/4) OF THE SOUTHWEST ONE-QUARTER (SW 1/4) OF SECTION 4, TOWNSHIP 40 SOUTH, RANGE 38 EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGIN AT THE EAST ONE-QUARTER (E 1/4) CORNER OF SAID SECTION 5, HAVING A GRID COORDINATE OF X-647,081.932, Y-977,856.994 BASED ON THE NAD 27 DATUM OF THE FLORIDA STATE PLANE COORDINATE SYSTEM, EAST ZONE; THENCE S $01^{\circ}08'39''$ W, ALONG THE EAST BOUNDARY OF SAID SECTION 5, A DISTANCE OF 1173.16 FEET; THENCE S 88°51'21" E, 80.00 FEET; THENCE S 01°08'39" W, 129.91 FEET TO A POINT ON THE EASTERLY PROJECTION OF THE SOUTH BOUNDARY OF SAID NORTHEAST ONE-QUARTER (NE 1/4) OF THE SOUTHEAST ONE-QUARTER (SE 1/4); THENCE S 89°45'50" W, ALONG SAID LINE, 476.17 FEET; THENCE N 56°09'33" E, 239.26 FEET TO A POINT ON A LINE 200.00 FEET WEST OF PARALLEL WITH SAID EAST BOUNDARY OF SECTION 5; THENCE N 01°08'39" E, ALONG SAID PARALLEL LINE, 1172.98 FEET TO A POINT ON THE NORTH BOUNDARY OF SAID NORTHEAST ONE-QUARTER (NE 1/4) OF THE SOUTHEAST ONE-QUARTER (SE 1/4); THENCE N 89°53'31" E, ALONG SAID NORTH BOUNDARY, 200.05 FEET TO THE POINT OF BEGINNING.


BEGIN AT THE WEST ONE-QUARTER (W 1/4) CORNER OF SAID SECTION 4, HAVING A GRID COORDINATE OF X-647,081.932, Y-977,856.994 BASED ON THE NAD 27 DATUM OF THE FLORIDA STATE PLANE COORDINATE SYSTEM, EAST ZONE; THENCE N 89°53'31" E, ALONG THE NORTH BOUNDARY OF SAID NORTHWEST ONE-QUARTER (NW 1/4) OF THE SOUTHWEST ONE-QUARTER (SW 1/4) OF SECTION 4, A DISTANCE OF 58.01 FEET; THENCE S 01°08'39" W, 1174.43 FEET TO A BOUNDARY OF THE PROPOSED FLORIDA POWER & LIGHT COMPANY LEVEE -MIDWAY 500KV LINE; THENCE N 88°51'21" W, ALONG SAID BOUNDARY, 11.00 FEET; THENCE N 00°39'10" E, 1093.21 FEET TO A POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST; THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE, HAVING A RADIUS OF 60.00 FEET, A CENTRAL ANGLE OF 67°36'53", AND AN ARC DISTANCE OF 70.81 FEET TO A POINT ON THE WEST BOUNDARY OF SAID SECTION 4 AND THE BOUNDARY OF SAID PROPOSED FLORIDA POWER & LIGHT COMPANY LEVEE - MIDWAY 500KV LINE; THENCE N 01°08'39" E, ALONG SAID BOUNDARIES, 24.84 FEET TO THE POINT OF

SAID LANDS LYING IN MARTIN COUNTY, FLORIDA, CONTAINING 20.328 SQUARE FEET (D.47 ACRES) MORE OR LESS.
