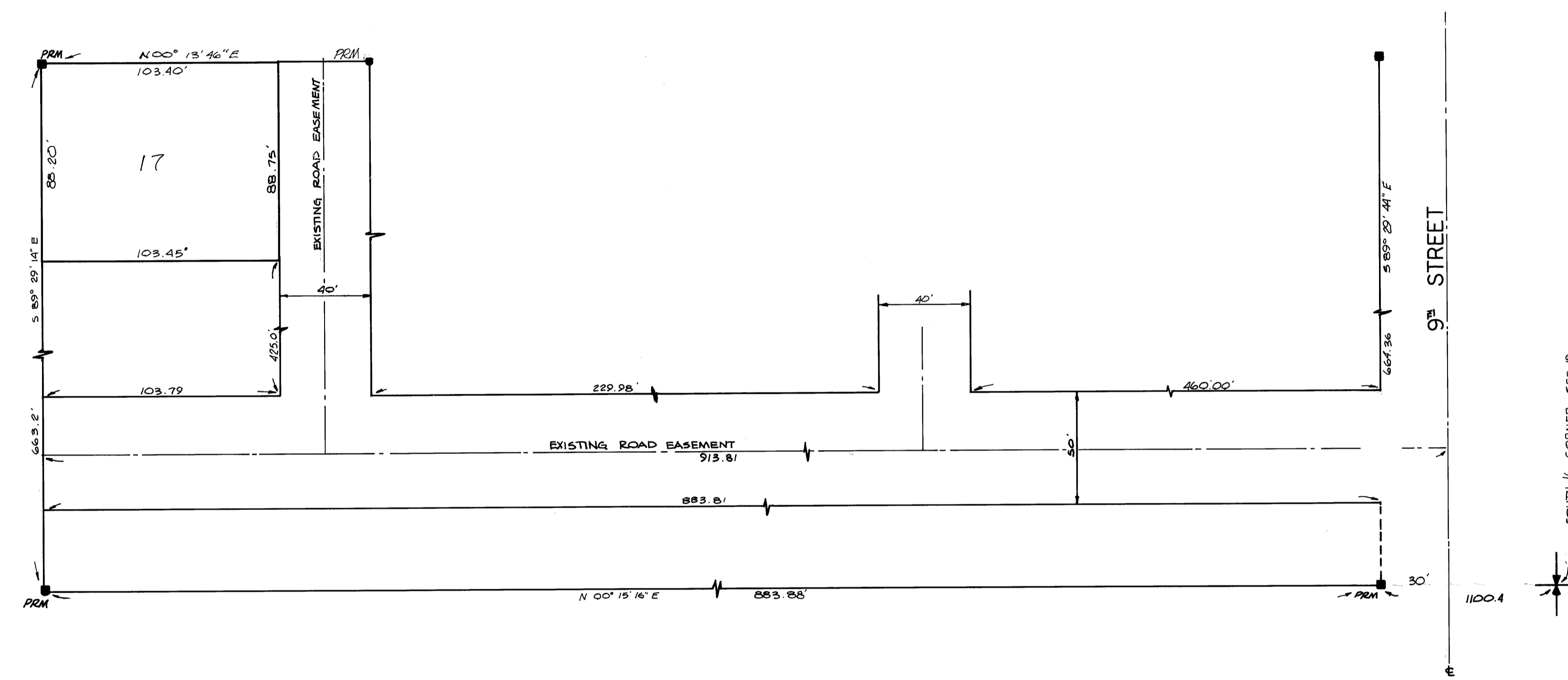
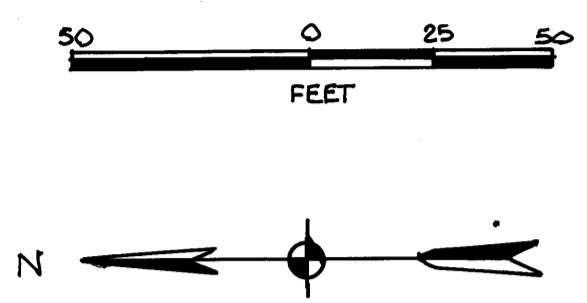
ZORATTI'S SUBDIVISION NO. 2
