

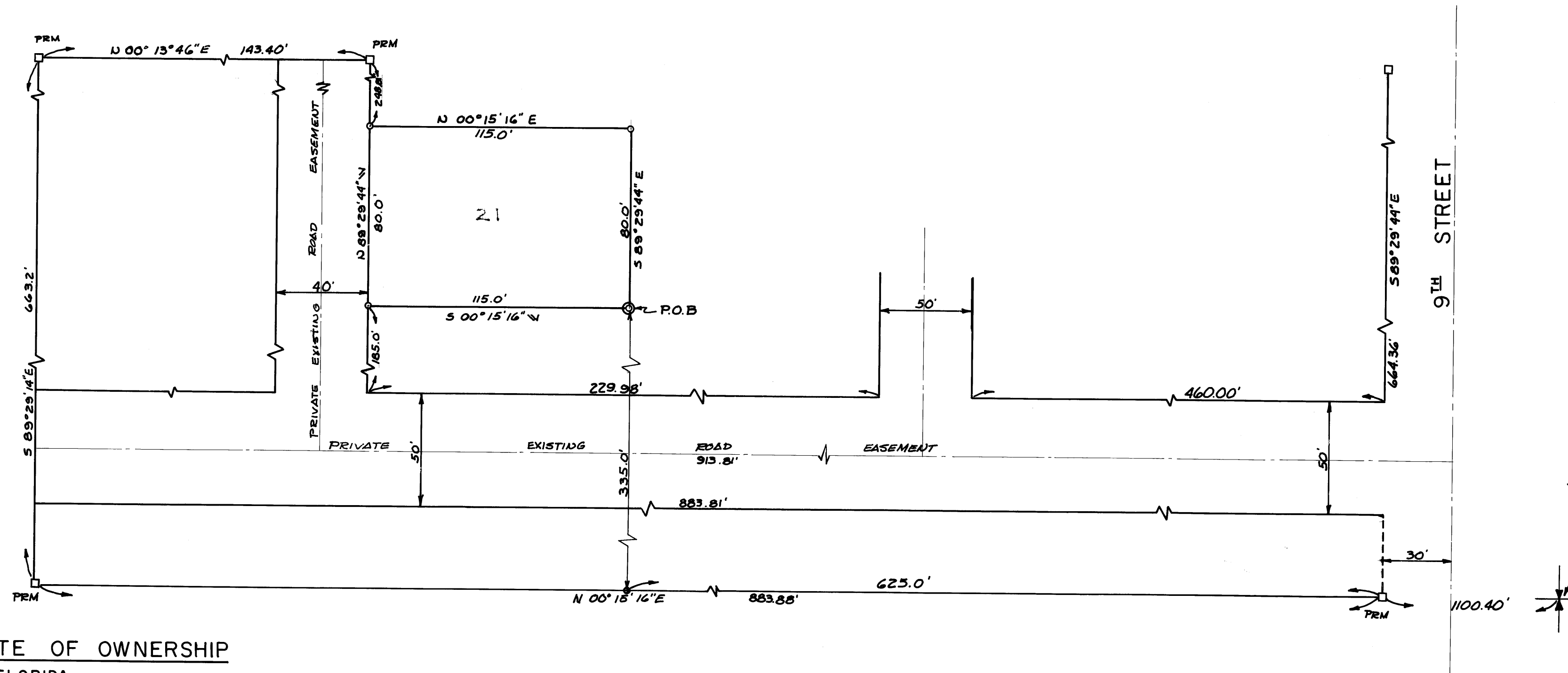
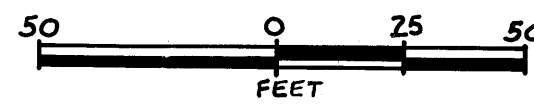
MINOR PLAT
