

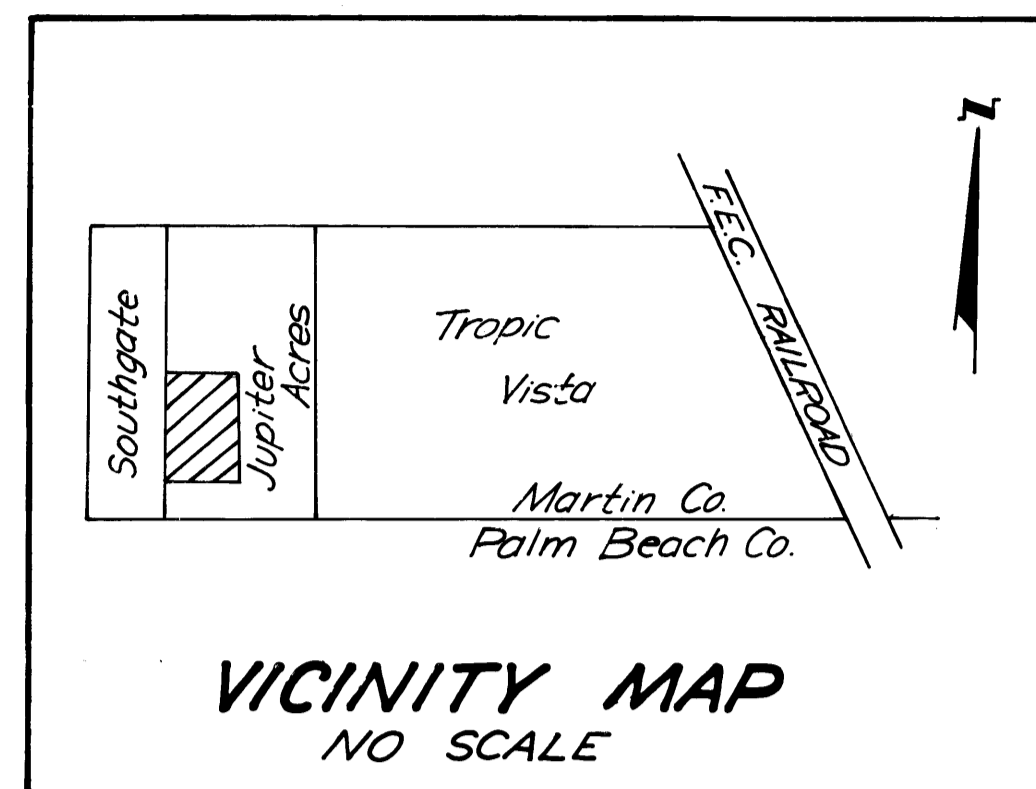

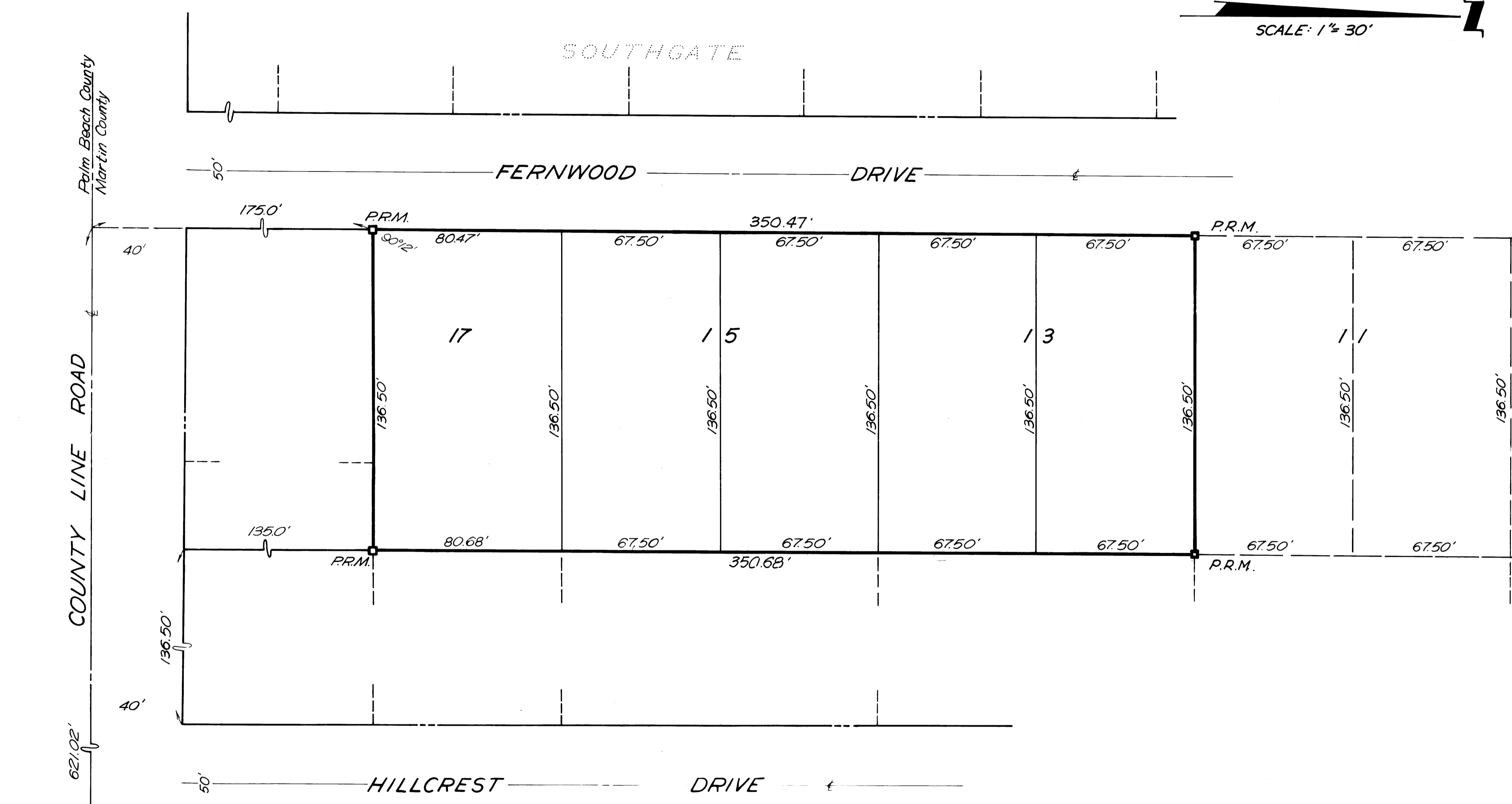
## MINOR PLAT
