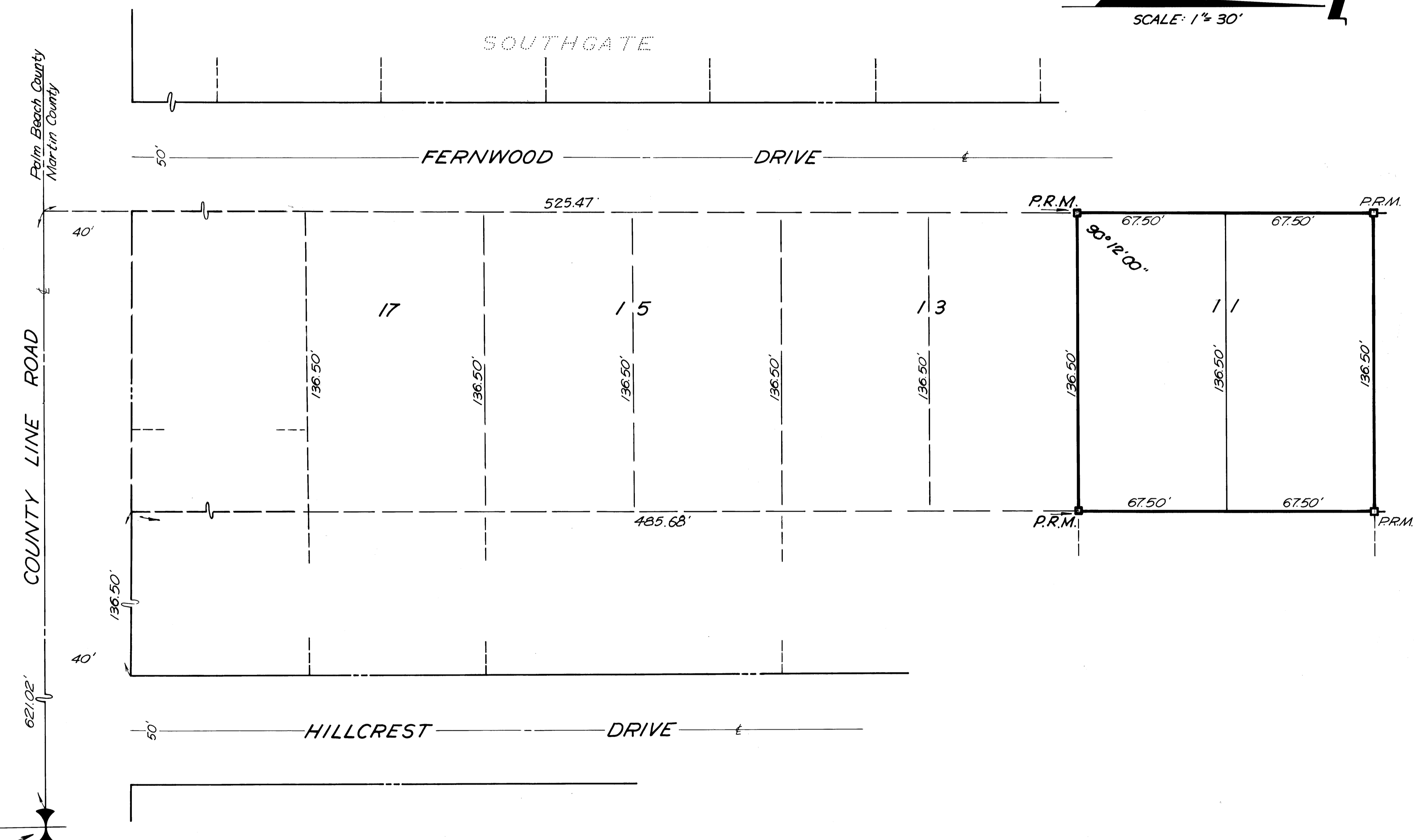
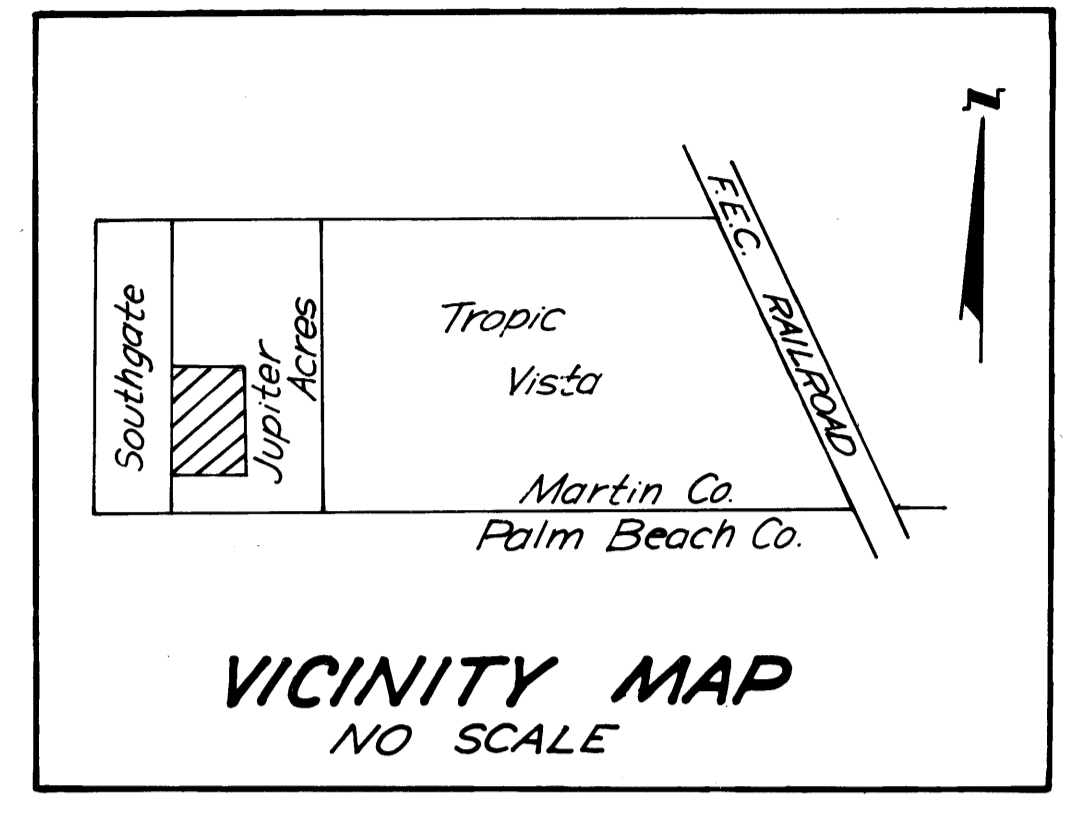


GIRARD #1
