BEFORE ME, THE UNDERSIGNED AUTHORITY, DULY AUTHORIZED IN THE STATE AND COUNTY AFORESAID TO ADMINISTER OATHS AND TAKE ACKNOWLEDGMENTS, PERSONALLY APPEARED Jack Noale AS COUNTY ADMINISTRATOR AND C.E. Rawleson, AS ROAD SUPERINTENDENT, WHO, AFTER BEING DULY SWORN, DEPOSE AND SAY ON OATH AS FOLLOWS:

1. WE, THE UNDERSIGNED, BEING COUNTY ADMINISTRATOR AND ROAD SUPERINTENDENT, RESPECTIVELY, OF MARTIN COUNTY, FLORIDA, AND AS SUCH DULY QUALIFIED EMPLOYEES OF SAID MARTIN COUNTY, DO AVER THAT WE ARE THOROUGHLY FAMILIAR WITH ALL OF THE ROADS IN MARTIN COUNTY, FLORIDA AND WITH THE PROGRAM OF MAINTENANCE AND IMPROVEMENT THEREOF THAT WE HAVE BEEN ASSOCIATED IN PRESENT OR SIMILAR CAPACITY ON ROAD PROGRAMS IN SAID COUNTY FOR A PERIOD IN EXCESS OF 5 YEARS.

FURTHER THAT THE MAINTENANCE OF SAID S.R. 707 CONSISTS OF MOWING, PERIODIC GRADING AND REPLACING OF MARL BASE MATERIAL.
