BEFORE ME, THE UNDERSIGNED AUTHORITY, DULY AUTHORIZED IN THE STATE AND COUNTY AFORESAID TO ADMINISTER OATHS AND TAKE ACKNOWLEDGMENTS, PERSONALLY APPEARED C.E. RAULERSON AS ROAD SUPERINTENDENT, WHO, AFTER BEING DULY SWORN, DEPOSES AND SAYS ON OATH AS FOLLOWS:

- I. I, THE UNDERSIGNED, BEING COUNTY ROAD SUPERINTENDENT OF MARTIN COUNTY, FLORIDA, AND AS SUCH A DULY QUALIFIED EMPLOYEE OF SAID MARTIN COUNTY, DO AVER THAT I AM THOROUGHLY FAMILIAR WITH ALL OF THE ROADS IN MARTIN COUNTY, FLORIDA AND WITH THE PROGRAM OF MAINTENANCE AND IMPROVEMENT THEREOF. THAT I HAVE BEEN ASSOCIATED IN PRESENT OR SIMILAR CAPACITY ON ROAD PROGRAMS IN SAID COUNTY FOR A PERIOD IN EXCESS OF 18 YEARS.
- 2. THAT TO MY PERSONAL KNOWLEDGE AND OBSERVATION THE ROAD KNOWN AND DESCRIBED AS S.E. VELASQUEZ AVENUE BETWEEN S.E. MONTEREY ROAD AND S.E. SEVILLE ROAD ALL WITHIN MARTIN COUNTY AS LOCATED AS SHOWN ON THE ABOVE MAR WAS CONSTRUCTED BY AND HAS BEEN MAINTAINED AND REPAIRED CONTINUOUSLY AND UNINTERRUPTED FOR 16 YEARS BY THE MARTIN COUNTY ROAD AND BRIDGE DEPARTMENT. FURTHER THAT THE MAINTENANCE OF SAID PORTION OF S.E. VELASQUEZ AVENUE CONSISTS OF MOWING, PERIODIC GRADING, REPLACING OF MARL BASE MATERIAL AND RECENT PAVING.
