

# LEGAL DESCRIPTION

THAT PORTION OF GOVERNMENT LOT 1, IN SECTION 30, TOWNSHIP 37 SOUTH, RANGE 42 EAST, LYING AND BEING IN MARTIN COUNTY, FLORIDA, DESCRIBED AS FOLLOWS:


