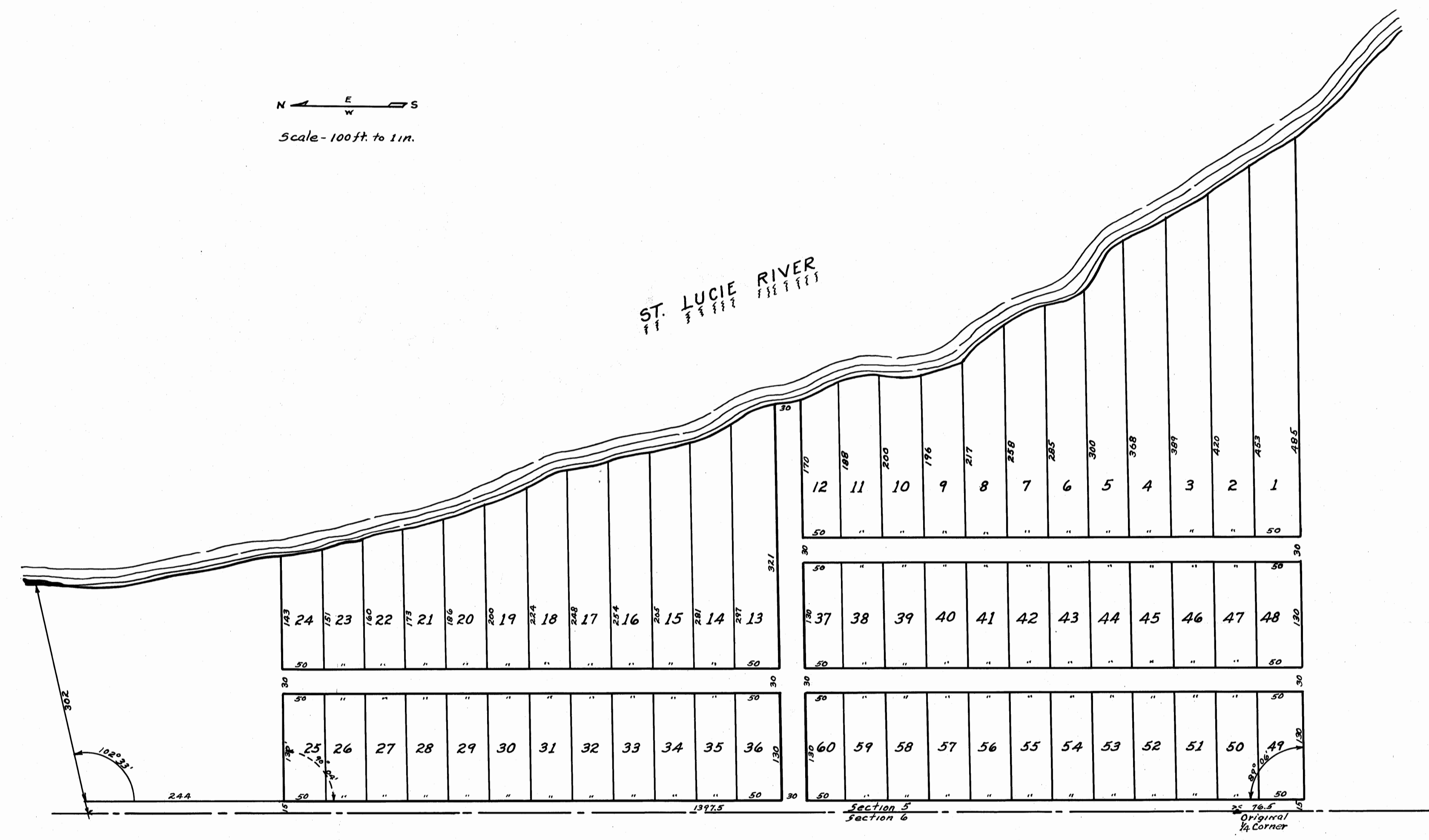
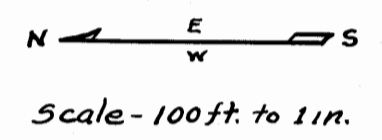

Know all men by these presents that the undersigned Carrie W. Webb, owner in fee simple of the tract of land shown on the attached plat, being parts of Lots 4 and 5 in Sec. 5, Tp. 38 S, R. 41 E, described as follows: Beginning at a point on the Section line between Secs. 5 and 6, Tp. 38 S, R. 41 E, 1133.5 feet North of the 1/4 sec. cor. between Secs. 5 and 6, thence running South on said sec. line to a point 148 feet south of said 1/4 sec. corner, thence East 820 feet to the St. Lucie River, thence along the bank of the St. Lucie River Northwesterly to a point 318 feet East of the point of beginning, thence West 318 feet to the point of beginning, together with all easements and riparian rights thereto belonging, has caused the attached plat to be made and the land subdivided as shown thereon, and hereby dedicates to the perpetual use of the public the streets as shown thereon.
