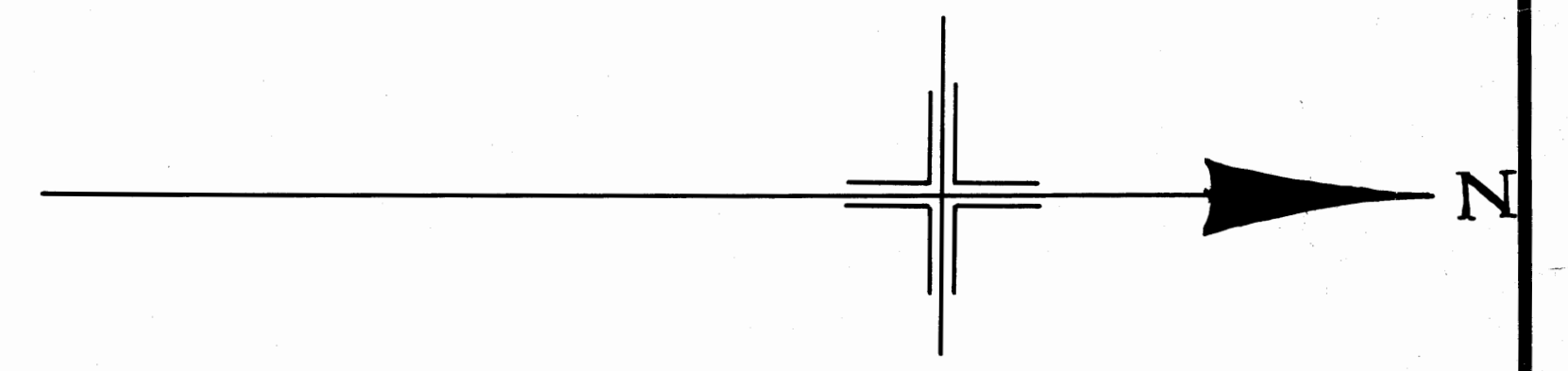
REVISED PLAT OF
