

KNOW ALL MEN BY THESE PRESENTS; that F.W. Sadler the purchaser under contract of that part of the Gomez Grant on Jupiter Island which lies North of a line running South 66° west said line being 96 feet Northwesterly measured at right angles to said line, from a Concrete monument on the Ocean ridge which marks the South line of lot 65 according to a plat of the subdivision of the Gomez Grant, on Jupiter Island as recorded in Plat Book 1, Page 80 public records of Palm Beach County, Florida, has caused a portion of said land to be surveyed and platted as shown on this map; that the said F.W. Sadler does hereby dedicate to the perpetual use of the public, the several streets and boulevard shown upon said plat, reserving however the reversion and reversions thereof to himself, his heirs, his executors and assigns whenever the said streets and boulevard shall be discontinued as such by the public or abandoned according to Law.
