## LOCATION

Being a subdivision of a portion of the North  $\frac{1}{3}$  of Lot 25 Gomez Grant, in T. 39 S., R. 42 E., Martin County, Florida, as recorded in Plat Book 1 Page 80 and described as follows to Wit:

Beginning at the North Westerly corner of Lot 25, thence N.66°E. 2107.43 feet distance to a point at waters edge of an artificial lagoon, thence N.84°46'E. 3921 feet to a point, thence S.50°34'E. 82.59 feet to a point, thence S.56°53'E. 76.37 feet to a point, thence N.88°15'E. 65.33 to a point, thence N.89°23'E. 110.73 feet to a point, thence S.66°W. and parallel to the first course. 2385.04 feet to a point on property line, thence N.24°W. 219.32 feet along property line and parallel to First Avenue (Old Military Trail) to the point of beginning.
