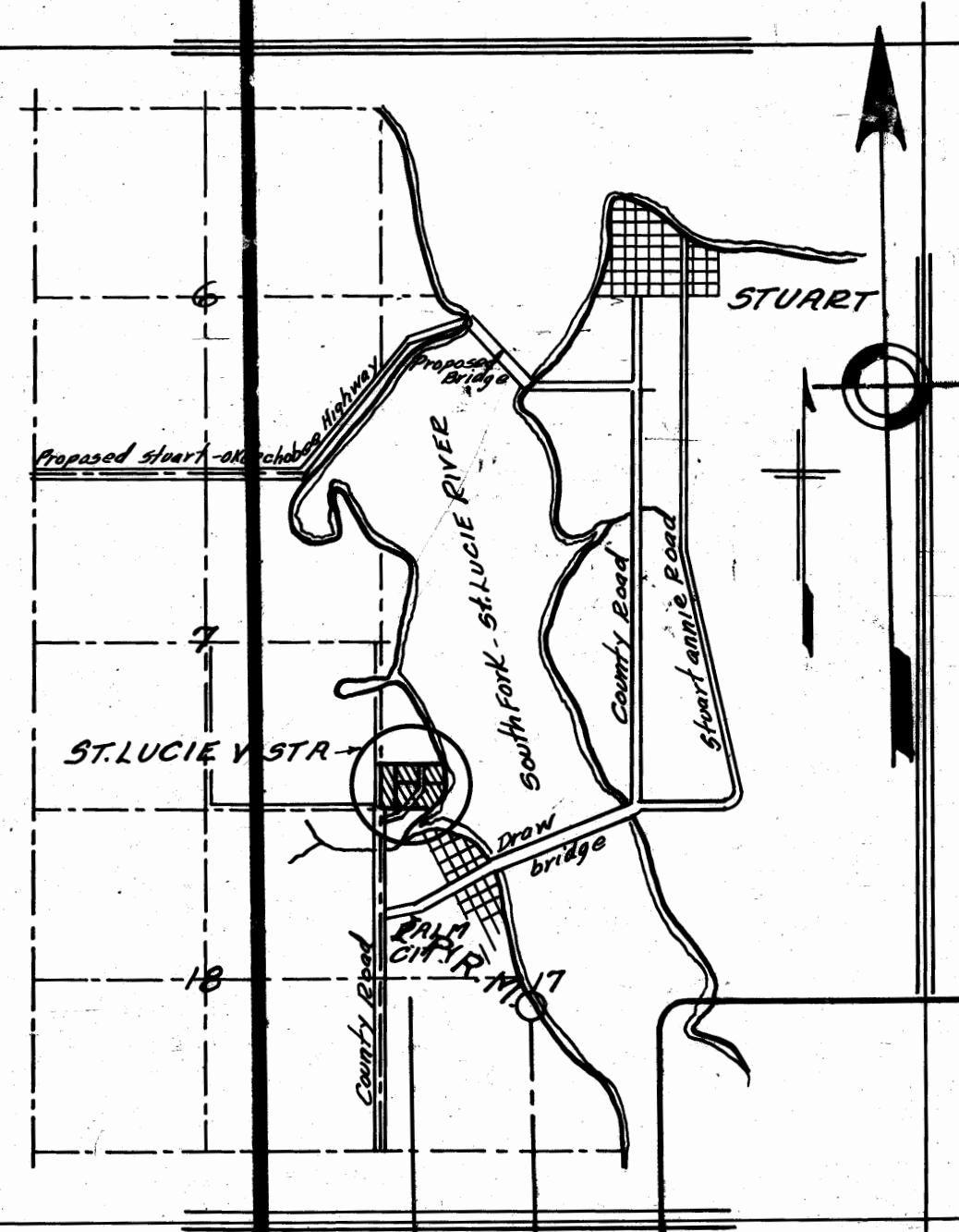
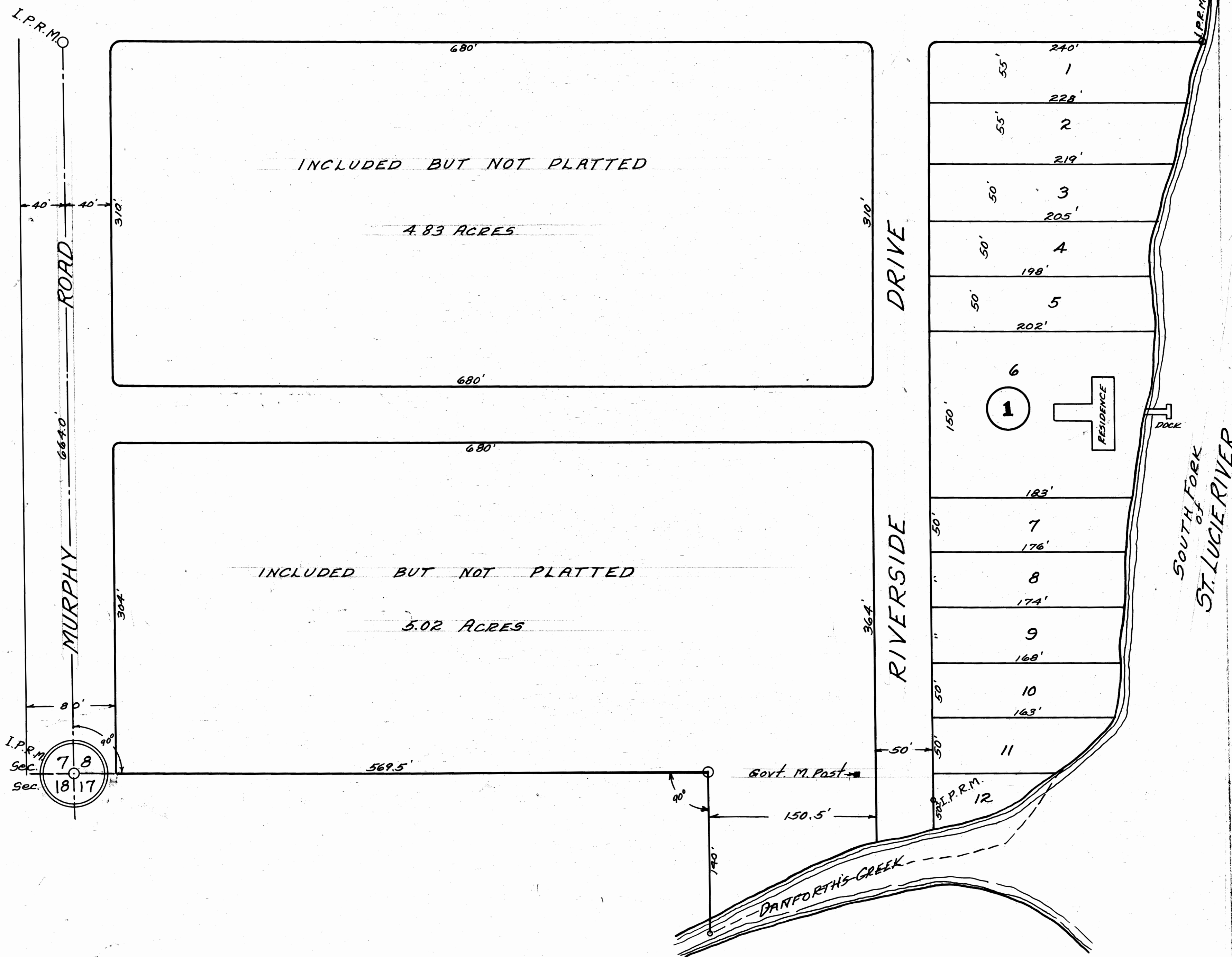
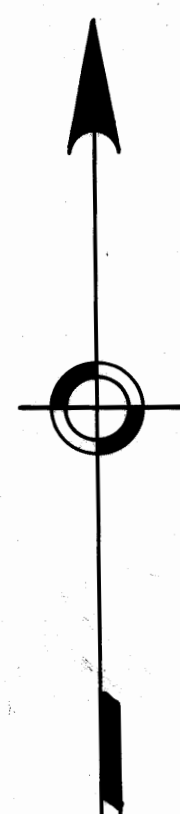

KNOW ALL MEN BY THESE PRESENTS, that I, Emma Helen Murphy, owner of the following described property, to-wit: a fractional part of Sec. 17, T. 38 S. R. 41 E. as follows: Beginning at a point on the north line of Sec. 17, said point being 569.5 feet from the northwest corner of Sec. 17, thence deflexing 90° to the right to the center line of Danforth's Creek, thence eastward by a meander line, along the center line of said creek to the mouth of Danforth's Creek, thence northward by the south corner of St. Lucie River to the intersection of said bank with the north line of said section 17, thence west along north line of sec. 17 to the place of beginning, have caused above described plots of land to be surveyed and replatted as shown hereon and do dedicate to the perpetual use of the public the streets and alleys shown hereon reserving however unto my successors, assigns or legal representatives the portion or portions of the same whenever appropriated by the public or discontinued by law.
