Know All Men by These Presents: That the Town of Paohokee, Florida, a Corporate political subdivision of the State of Florida, located in Palm Beach County, Florida, the owner in fee simple of that tract of land lying and being in Martin County, Florida, shown on the attached plat as Paohokee Cemetery, and more particularly described as follows: To wit: Beginning at the Southeast corner of the Northeast quarter of Section 19, Township 40 South, Range 27 East; thence run North or 09°30' East along the east line of said Section 19, a distance of 459.55 feet to a point which point is South 0°09' 94" West a distance of 2220.80 feet from the Northeast corner of said Section 19; thence running South 89°53' 94" West a distance of 459.11 feet to a point; thence run South 0°07' 54" West a distance of 459.62 feet to the intersection with the south line of the Northeast quarter of Section 19; thence run North 89°53' 24.7" East along this quarter section line a distance of 452.85 feet to the place of beginning; has caused the same to be surveyed and platted as shown on the attached plat, and does hereby dedicate to the perpetual use of the public all the roadways, paths, planting areas, and parks as shown thereon.
