

A PARCEL OF LAND LYING IN SECTION 17, TOWNSHIP 38 SOUTH, RANGE 42 EAST, MARTIN COUNTY, FLORIDA; SAID PARCEL BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE MOST NORTHERLY CORNER OF GOLF COURSE PARCEL NO. "L", PLAT NO. 6 SAILFISH POINT, P.U.D., AS RECORDED IN PLAT BOOK 8, PAGE 90, PUBLIC RECORDS OF MARTIN COUNTY, FLORIDA, SAID POINT LYING ON THE SOUTHERLY RIGHT-OF-WAY OF S.E. DUNE DRIVE, AS SHOWN ON PLAT NO. 7 SAILFISH POINT, P.U.D., AS RECORDED IN PLAT BOOK 9, PAGE 13, PUBLIC RECORDS OF MARTIN COUNTY, FLORIDA; THENCE ALONG THE NORTH LINE OF SAID GOLF COURSE PARCEL NO. "L" THROUGH THE FOLLOWING

S 46°47'00" W, A DISTANCE OF 513.13 FEET TO A POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTH HAVING A RADIUS OF 146.05 FEET; THENCE WESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 51°13'00", AN ARC DISTANCE OF 130.55 FEET TO THE POINT OF TANGENCY; THENCE N 82°00'00" W, A DISTANCE OF 116.46 FEET TO A POINT ON THE EASTERLY LINE OF PLAT NO. 5 SAILFISH POINT, P.U.D., AS RECORDED IN PLAT BOOK 8, PAGE 89, PUBLIC RECORDS OF MARTIN COUNTY, FLORIDA; THENCE ALONG THE EAST LINE OF SAID PLAT NO. 5 SAILFISH POINT, P.U.D., THROUGH THE FOLLOWING COURSES:

THENCE N 14°45'10" W, A DISTANCE OF 59.36 FEET TO A POINT OF CURVATURE OF A CURVE CONCAVE TO THE EAST HAVING A RADIUS OF 144.77 FEET; THENCE NORTHERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 30°53'24", AN ARC DISTANCE OF 78.05 FEET TO THE POINT OF TANGENCY; THENCE N 16°08'14" E, A DISTANCE OF 125.00 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE WEST HAVING A RADIUS OF 99.84 FEET; THENCE NORTHERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 43°40'04", AN ARC DISTANCE OF 76.09 FEET TO A POINT: THENCE LEAVING SAID EAST LINE N 27°31'50" W, A DISTANCE OF 4.82 FEET; THENCE N 69°30'00" E, A DISTANCE OF 26.66 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 265.79 FEET; THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 43°33'37", AN ARC DISTANCE OF 202.07 FEET TO THE POINT OF REVERSE CURVATURE OF A CURVE CONCAVE TO THE SOUTHEAST HAVING A RADIUS OF 25.00 FEET, SAID POINT ALSO BEING ON THE BOUNDARY OF SAID PLAT NO. 7 SAILFISH POINT, P.U.D.; THENCE ALONG SAID BOUNDARY AND CURVE SOUTHEASTERLY THROUGH A CENTRAL ANGLE OF 80°05'56", AN ARC DISTANCE OF 34.95 FEET TO THE POINT OF TANGENCY; THENCE S 73°57'41" E, A DISTANCE OF 414.50 FEET TO THE POINT OF BEGINNING.

- 1. THE UTILITY EASEMENT AS SHOWN HEREON MAY BE USED FOR UTILITY PURPOSES BY ANY UTILITY COMPANY, INCLUDING C.A.T.V., IN COMPLIANCE WITH SUCH ORDINANCES AND REGULATIONS AS MAY BE ADOPTED FROM TIME TO TIME BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA.
- 2. S.E. LAKEVIEW TERRACE AS SHOWN HEREON IS HEREBY DEDICATED TO SAILFISH POINT PROPERTY OWNERS' AND COUNTRY CLUB ASSOCIATION, INC., OR ITS ASSIGNS, FOR PRIVATE STREET PURPOSES, UTILITY, LANDSCAPE AND DRAINAGE PURPOSES; THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, SHALL BEAR NO RESPONSIBILITY, DUTY OR LIABILITY REGARDING SAID S.E. LAKEVIEW TERRACE.
