THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY SHALL BEAR NO RESPONSIBILITY, DUTY OR LIABILITY REGARDING SAID S. W. HUNTER'S CLUB WAY, S. W. SAND OAK DRIVE AND S. W. HUNT CLUB CIRCLE.
- 2. THE UTILITY EASEMENTS , SHOWN ON THIS PLAT OF HUNTER'S CREEK P.U.D. MAY BE USED FOR UTILITY PURPOSES BY ANY UTILITY (INCLUDING C.A.T.V.) IN COMPLIANCE WITH SUCH ORDINANCES AND REGULATIONS AS MAY BE ADOPTED FROM TIME TO TIME BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY AND APPROVED BY THE HUNTER'S CREEK PROPERTY OWNERS ASSOCIATION, INC. THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY SHALL BEAR NO RESPONSIBILITY, DUTY OR LIABILITY REGARDING SAID EASEMENTS.
- THE WETLANDS PRESERVATION AREAS AND THE NATIVE VEGETATION PRE-SERVATION AREAS SHOWN ON THIS PLAT OF HUNTER'S CREEK P.U.D. ARE HEREBY DEDICATED TO THE HUNTER'S CREEK PROPERTY OWNERS ASSOCIA-TION, INC. FOR PRESERVATION OF WETLANDS AND OF NATIVE VEGETATION AND SHALL BE THE PERPETUAL MAINTENANCE OBLIGATION OF SAID ASSO-CIATION. THERE SHALL BE NO ALTERATION OF SAID AREAS EXCEPT IN COMPLIANCE WITH THE PRESERVE AREA MANAGEMENT PLAN APPROVED BY MARTIN COUNTY. THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY SHALL BEAR NO RESPONSIBILITY, DUTY OR LIABILITY REGARD-ING SAID PRESERVATION AREAS.
- 4. THE DRAINAGE EASEMENTS, SHOWN ON THIS PLAT OF HUNTER'S CREEK OWNERS ASSOCIATION, INC. FOR DRAINAGE PURPOSES AND SHALL BE THE PERPETUAL MAINTENANCE OBLIGATION OF SAID ASSOCIATION. THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY SHALL BEAR NO RESPONSIBILITY, DUTY OR LIABILITY REGARDING SAID EASEMENTS.
- 5. THE PRESERVATION EASEMENTS, SHOWN ON THIS PLAT OF HUNTER'S CREEK P.U.D. ARE HEREBY DEDICATED TO THE HUNTER'S CREEK PRO-PERTY OWNERS ASSOCIATION, INC. FOR PRESERVATION OF NATIVE VEGE-TATION AND SHALL BE THE PERPETUAL MAINTENTANCE OBLIGATION OF SAID ASSOCIATION. THERE SHALL BE NO ALTERATION OF SAID EASE-MENTS EXCEPT IN COMPLIANCE WITH PRESERVE AREA MANAGEMENT PLAN APPROVED BY MARTIN COUNTY. THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY SHALL BEAR NO RESPONSIBILITY, DUTY OR LIA-BILITY REGARDING SAID EASEMENTS.
- 6. THE LIFT STATION EASEMENT SHOWN ON THIS PLAT OF HUNTER'S CREEK P.U.D. IS HEREBY DEDICATED TO THE HUNTER'S CREEK PROPERTY ASSOCIATION, INC. FOR THE MAINTENANCE AND OPERATION OF THE SANITARY LIFT STATION AND ACCESSORIES APPURTEMENT THERETO. 


