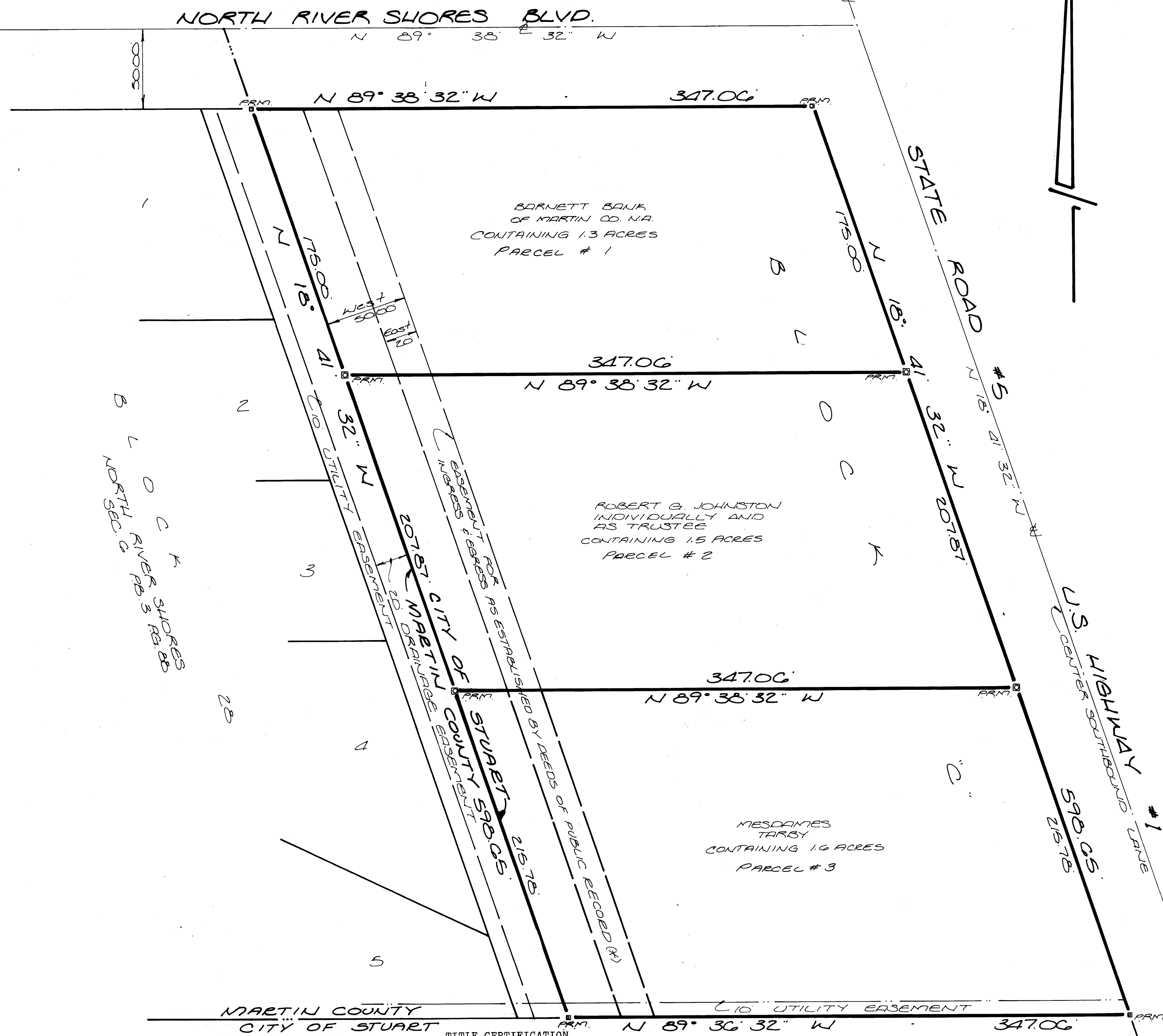


LOCATION MAP
