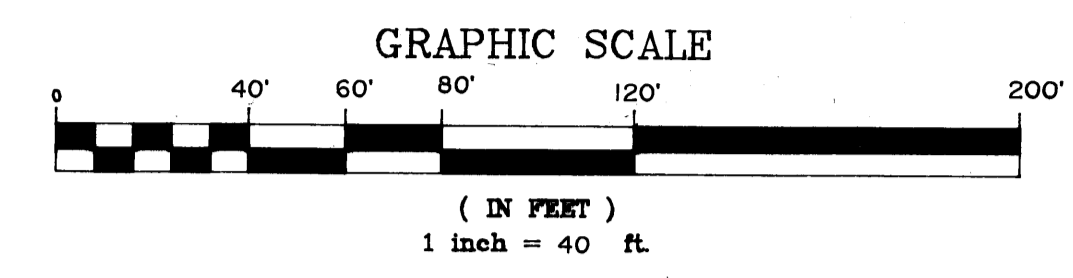
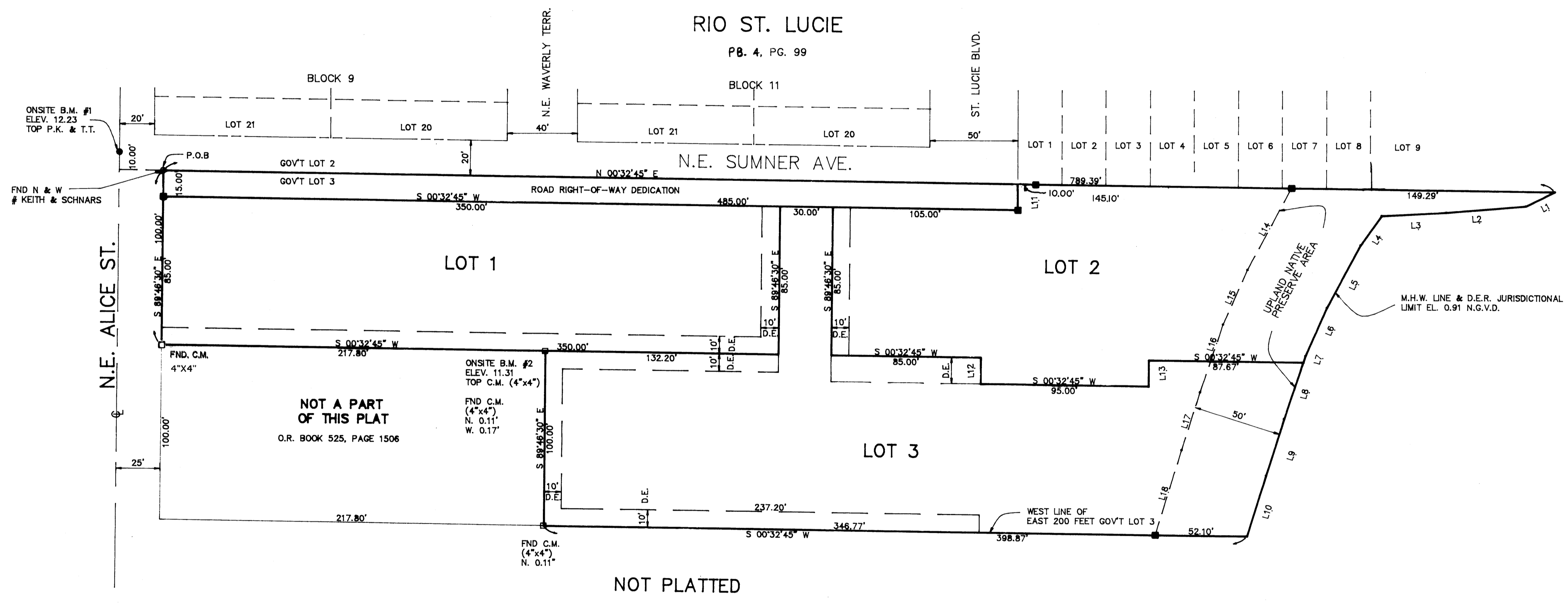


# PLAT OF HUNTING SUBDIVISION
