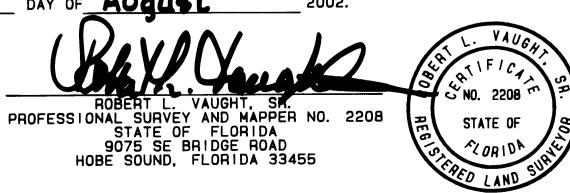

PRM DENOTES PERMANENT REFERENCE MONUMENT DENOTES PERMANENT CONTROL POINTS

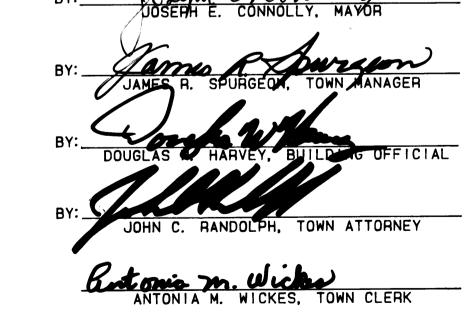
POINT OF INTERSECTION
