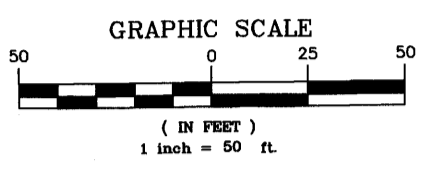


# MARTIN'S CROSSING P.U.D.

### SURVEY NOTES

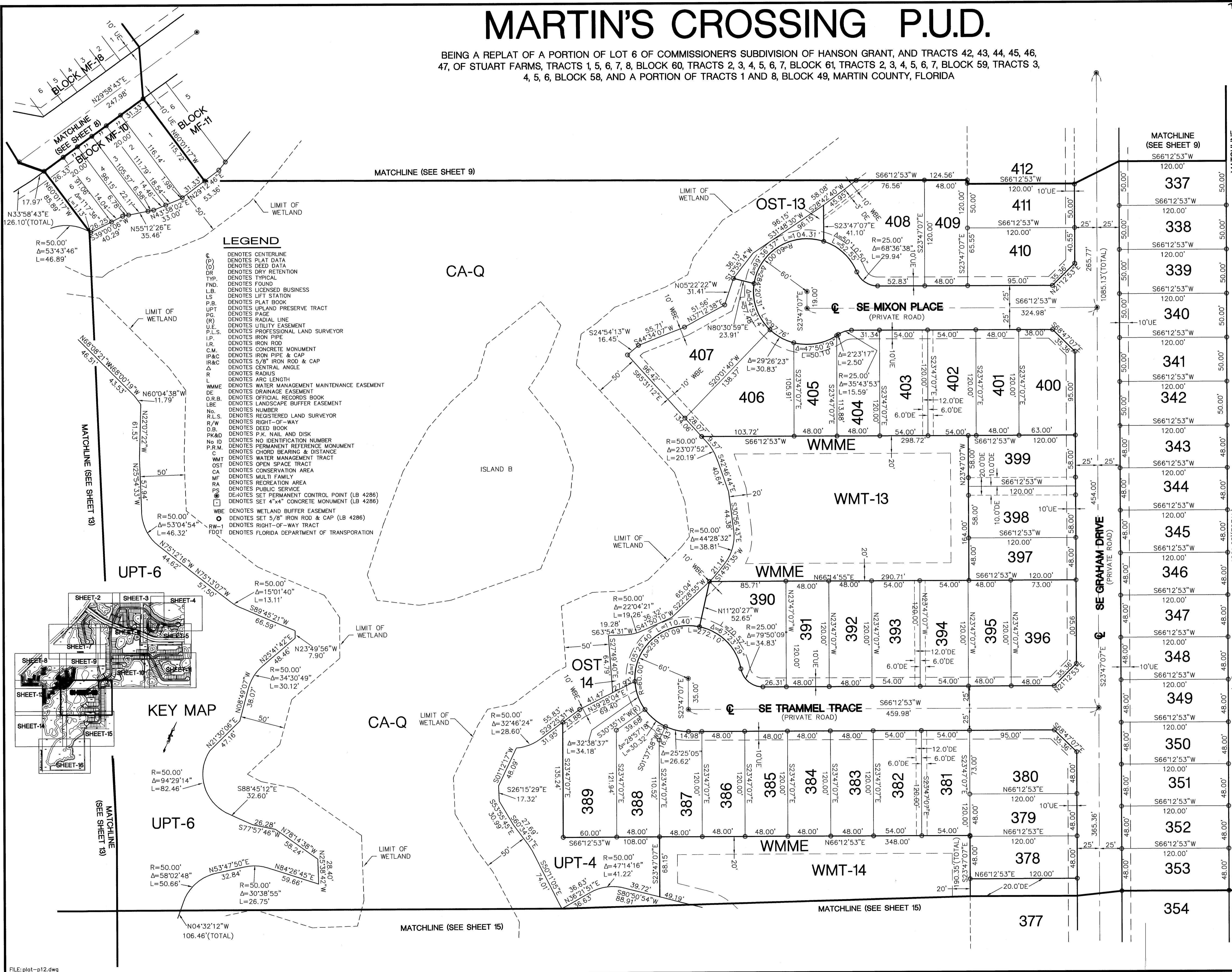
