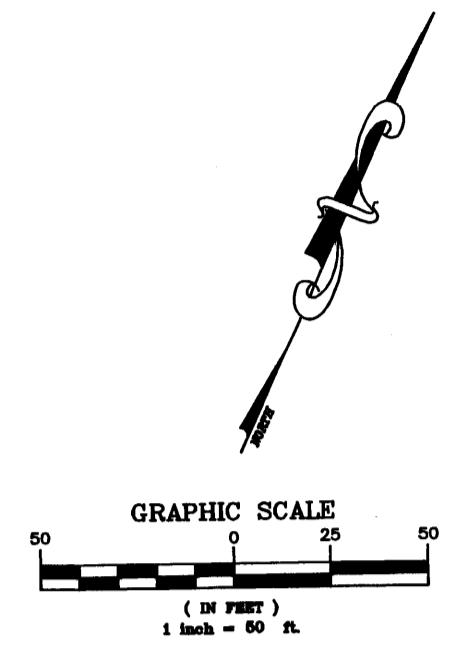


MARTIN'S CROSSING P.U.D.

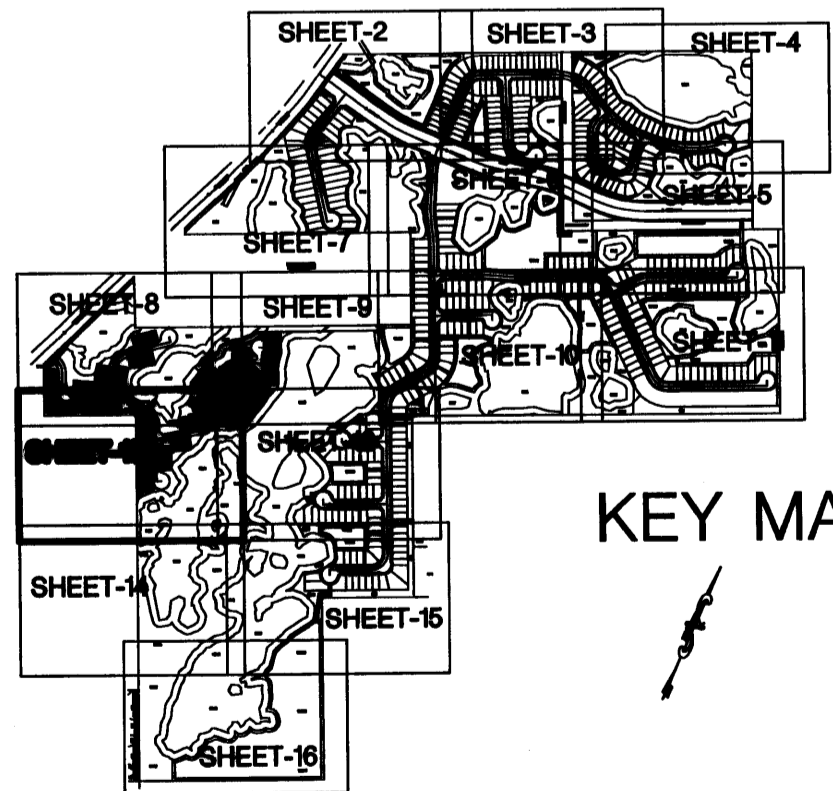
