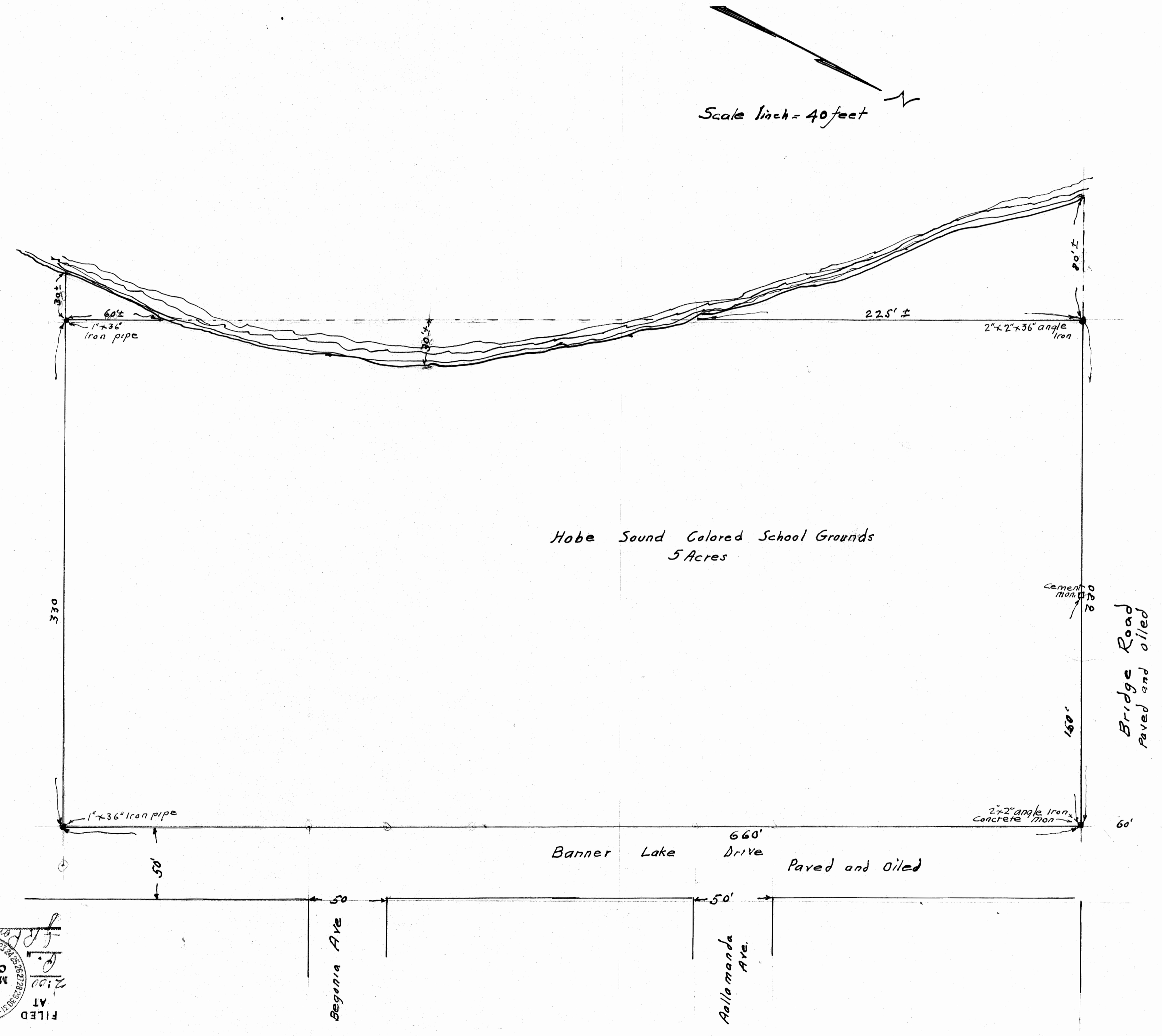

Description

Being a 5 Acre Tract of Land on the South side of Bridge Road and on the West side of Banner Lake Drive, Gomez Grant, according to PLat No. 3 of the Olympia Improvement Corporation said PLAT recorded in the Public Records of Palm Beach County, Florida in Book of Plats 90, Page 17, on April 19th 1924, Being a Subdivision of Gomez Grant, recorded in Palm Beach County in Book 1 of Plats, page 62 T385, R 42E

Begin at a point 1841.5 feet measured Westerly from the NW corner of Lot 86 in said Gomez Grant Plat, along the south line of Bridge Road to the intersection of the West line of Banner Lake Drive and the said South line of Bridge Road for a point of beginning. (a 4' square mon is set at this corner) Thence (1) run Southerly along the said West line Banner Lake Drive 660 feet to a 1" iron pipe Thence (2) run Westerly parallel with Bridge Road 330 feet to a 1" iron pipe Thence (3) run Northerly, parallel with Banner Lake Drive 660 feet to an angle iron in the South line of Bridge Road Thence (4) run Easterly 330 feet along the South line of Bridge Road to a 4' square cement monument the point or place of beginning containing 5 Acres of Land
