anow All men by these presents: That Anita R. Tilton and W. B. Tilton, her husband, owners of the tract of land shown hereon:

The following described property which includes BLOCK 1 of JENSEN according to Plat thereoffiled 14 January, 1901, recorded in Plat Book A, Page 138, Brevard County, Florida, public records. Commencing at the N.W. Cor. of the N.E. quarter, of Sec. 22, T 37 S., R 41 E., thence South along the quarter Sec. line a distance of 1368 feet, to a point, thence N 72° 05' E., 119 feet for a point of beginning. Thence continue N 72° 05'E., 774 feet to the shore line of the Indian River, themee Southerly along the shore line of the rivera distance of 363 feet plus or minus to a point; thence S. 72°42'W., 108 feet to the West R/W line of State Road 140, thence Southerly along the west R/W line of said road and distance of 37.62' feet to a point, thence by direct angle to the left 87°07', run Westerly along the northerly R/W line of Commercial Street a distance of 618 feet to a point, thence by direct angle to left 92°38' a distance of 162 feet to a point, thence by angle 87°22' left a distance of 65 feet to the easterly R/W line of the F.E.C. Ry; theme northerly along the easterly R/W line of said F.E.C. Ry. 251.1 feet to the point of beginning. With the exception of a atrip of land 10 feet wide and 520 feet long running from the shore line of the Indian River along the northerly side of property; has causied the same to be surveyed and platted, and does hereby dedicate to the public, the streets and roads as shown on plat herewith. Reserving unto themselves their successors and assigns, the reversion or reversions of any or all of said dedicated streets or roads whenever abandoned by the public or discontinued by law.
