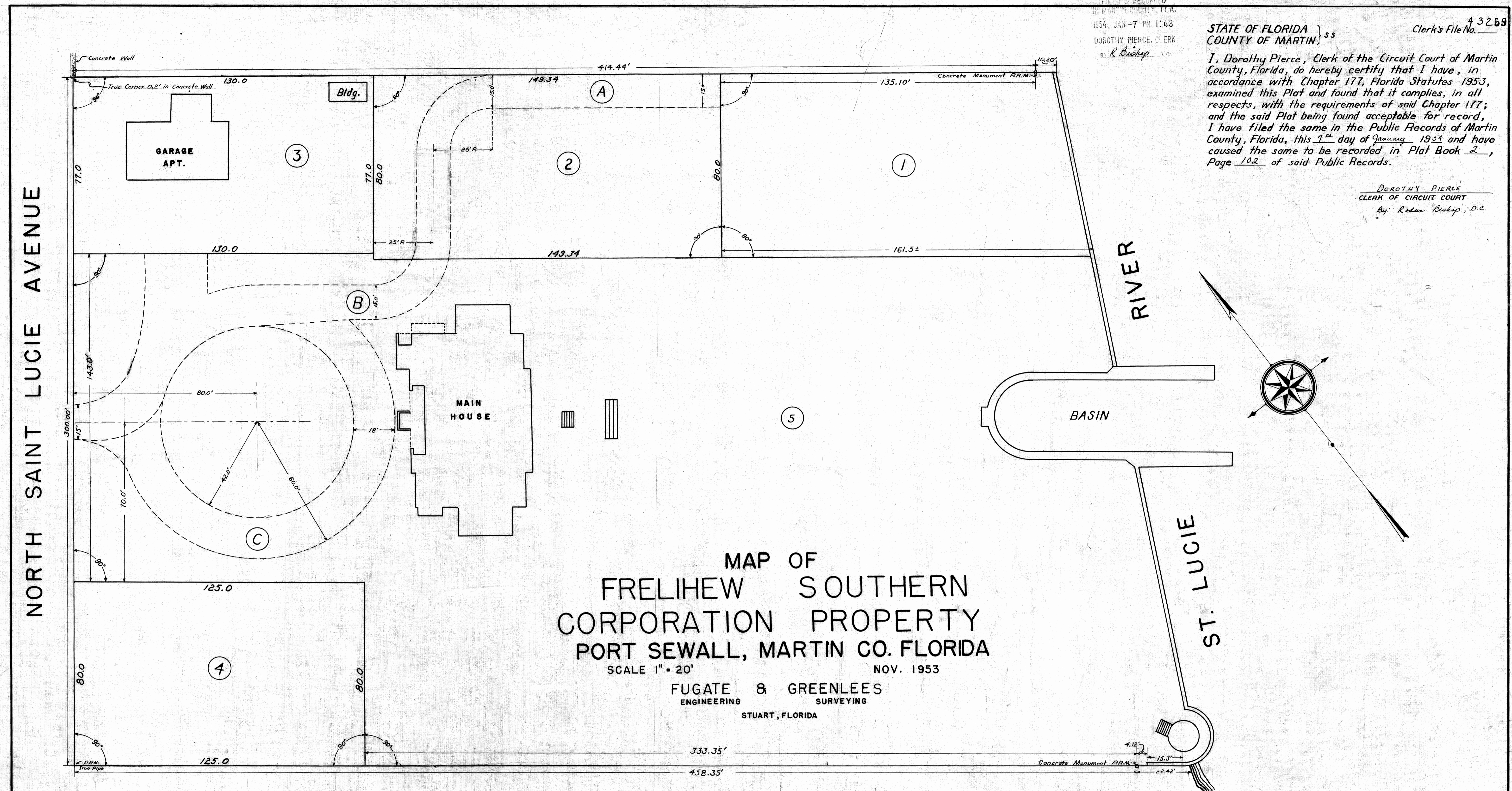

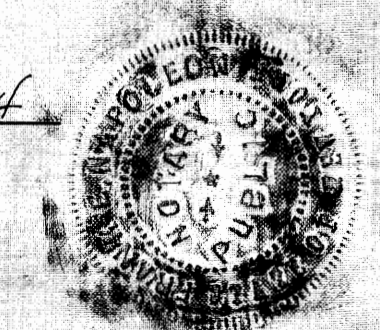


MAP OF

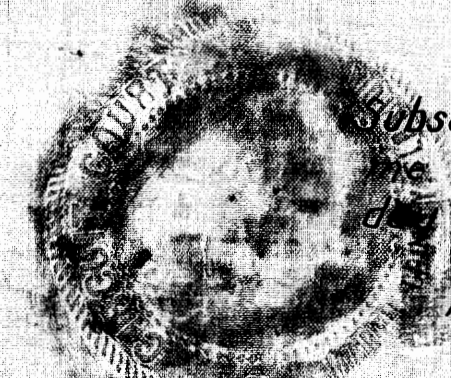
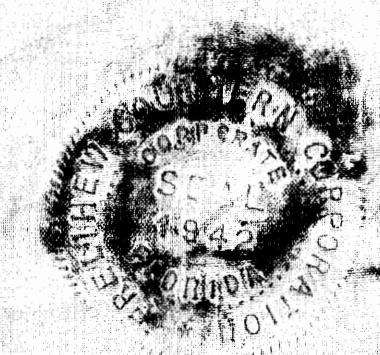
Know all men by these presents, that **FRELIHEW SOUTHERN CORPORATION**, has caused to be made, for purposes of reference, identification and convenience only, the foregoing attached map, privately dividing into numbered and lettered areas, the following described lands in **MARTIN COUNTY, FLORIDA**, to-wit: The south 300 feet of Lot W 23 (also marked "HOTEL GROUNDS") according to revised plat of Sewall's Point Land Co. subdivision filed in Plat Book 3, Page 8, Palm Beach County Records, said lands being more particularly described in deed dated August 27, 1952 recorded in Deed Book 58, Page 423, etc., Martin County Records. To be known as "FRELIHEW SOUTHERN CORPORATION PROPERTY, PORT SEWALL"; that it hereby dedicates the said plat only for the sole purpose of placing the same on public record in Martin County, Florida, expressly reserving unto itself, its successors and assigns, all right, title and interest in and to the lands and premises embraced therein (including but not limiting the same to all riparian rights, easements and reversions), it being intended that no driveways, streets, and/or alleys be designated thereby as such, any existing or future driveways or roads being reserved as private only, and appurtenant to the use by owner of the numbered portions of said lands adjoining the same and not subject to acceptance by or in behalf of the general public or any municipal authority unless and until subsequently dedicated as such.
