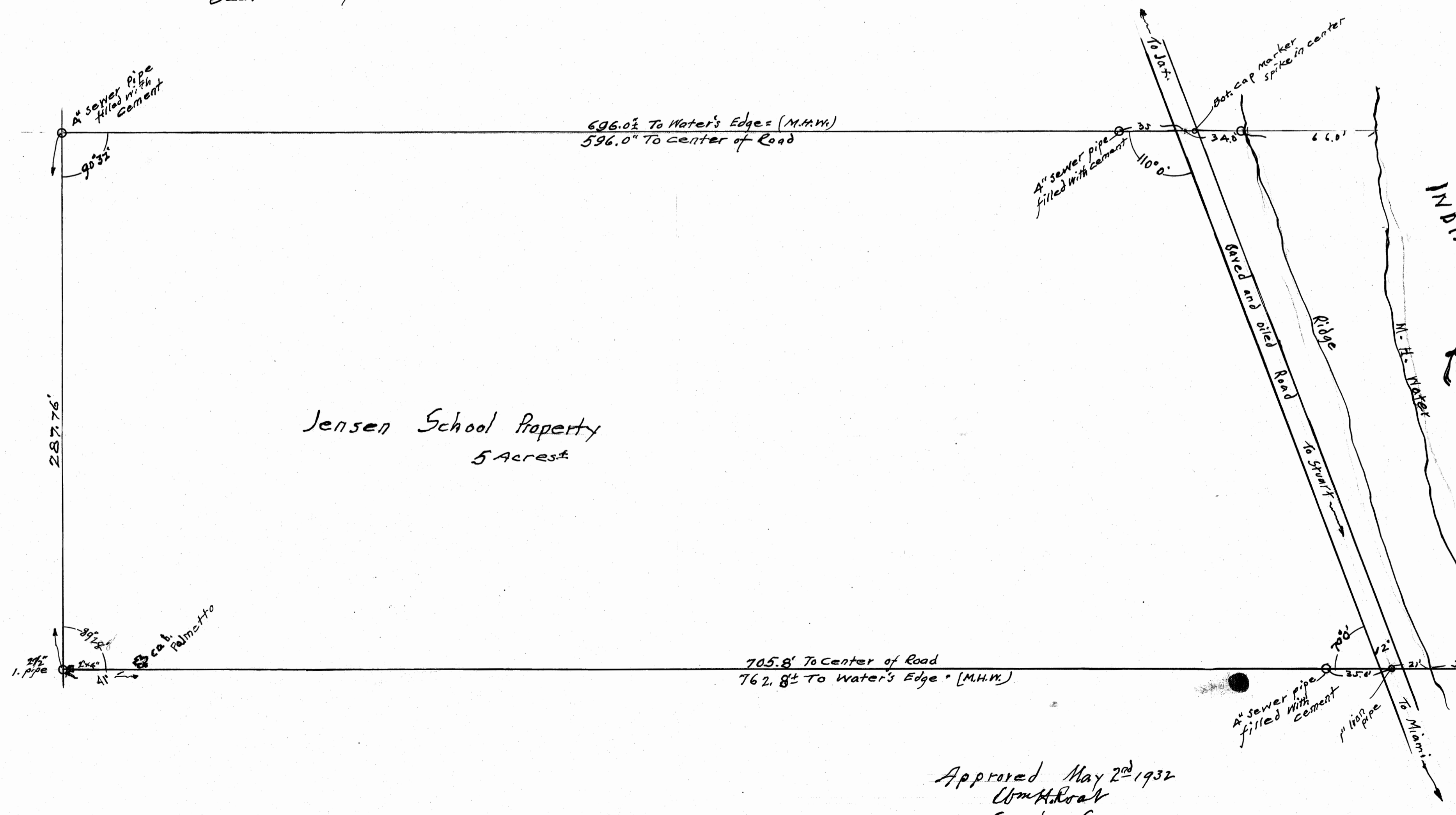
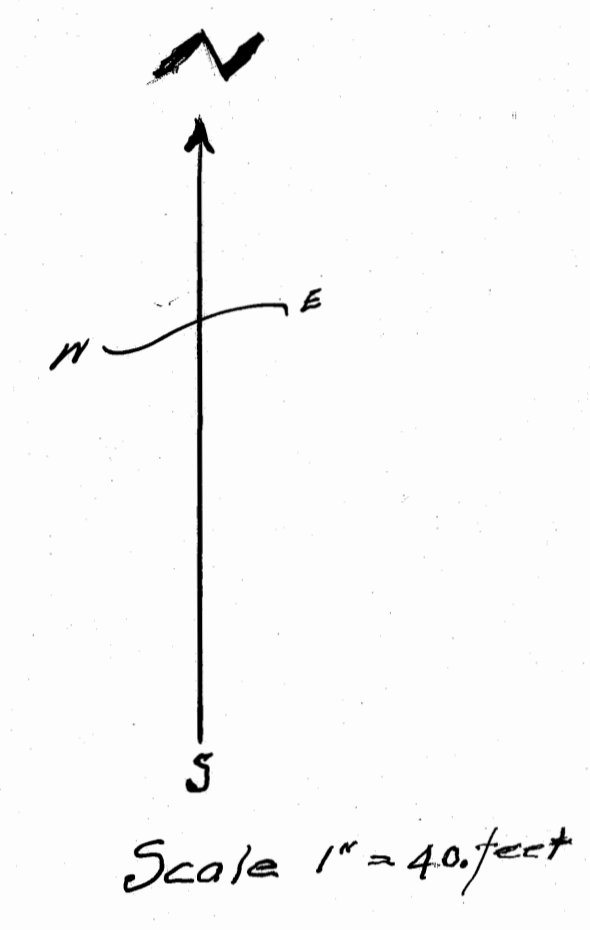

Water on West shore of Indian River. Thence (3) Meander Northwesterly said M.H. Water of Indian River 307.02 to a point that is 287.76 feet Due North of Line # 2.
