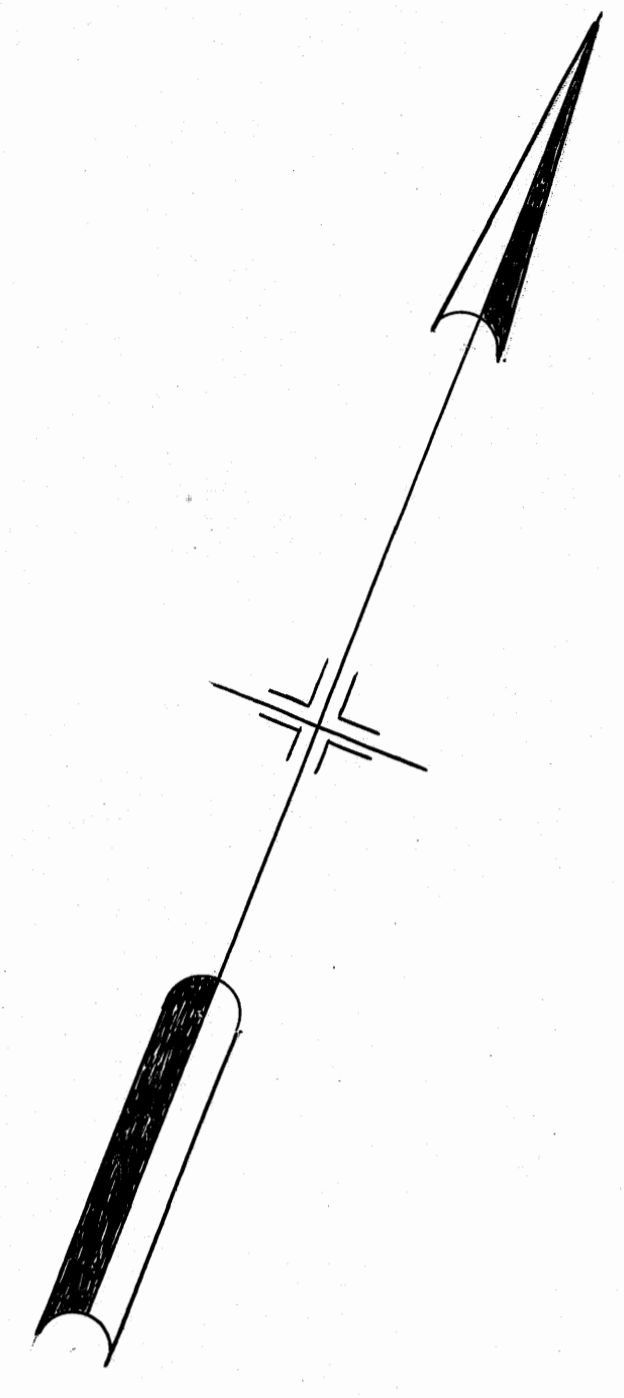

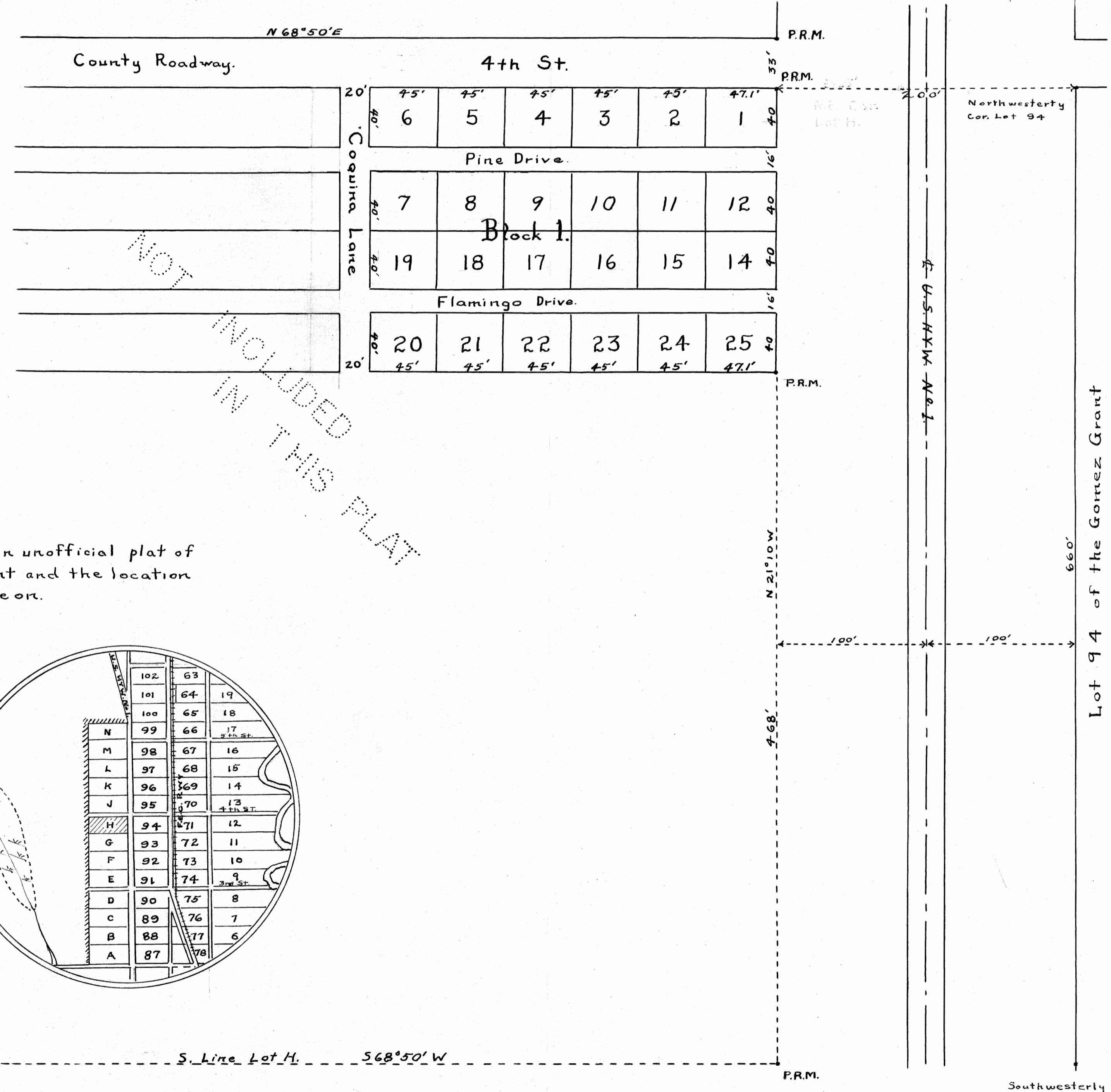

 record Sept 13th, 1892.

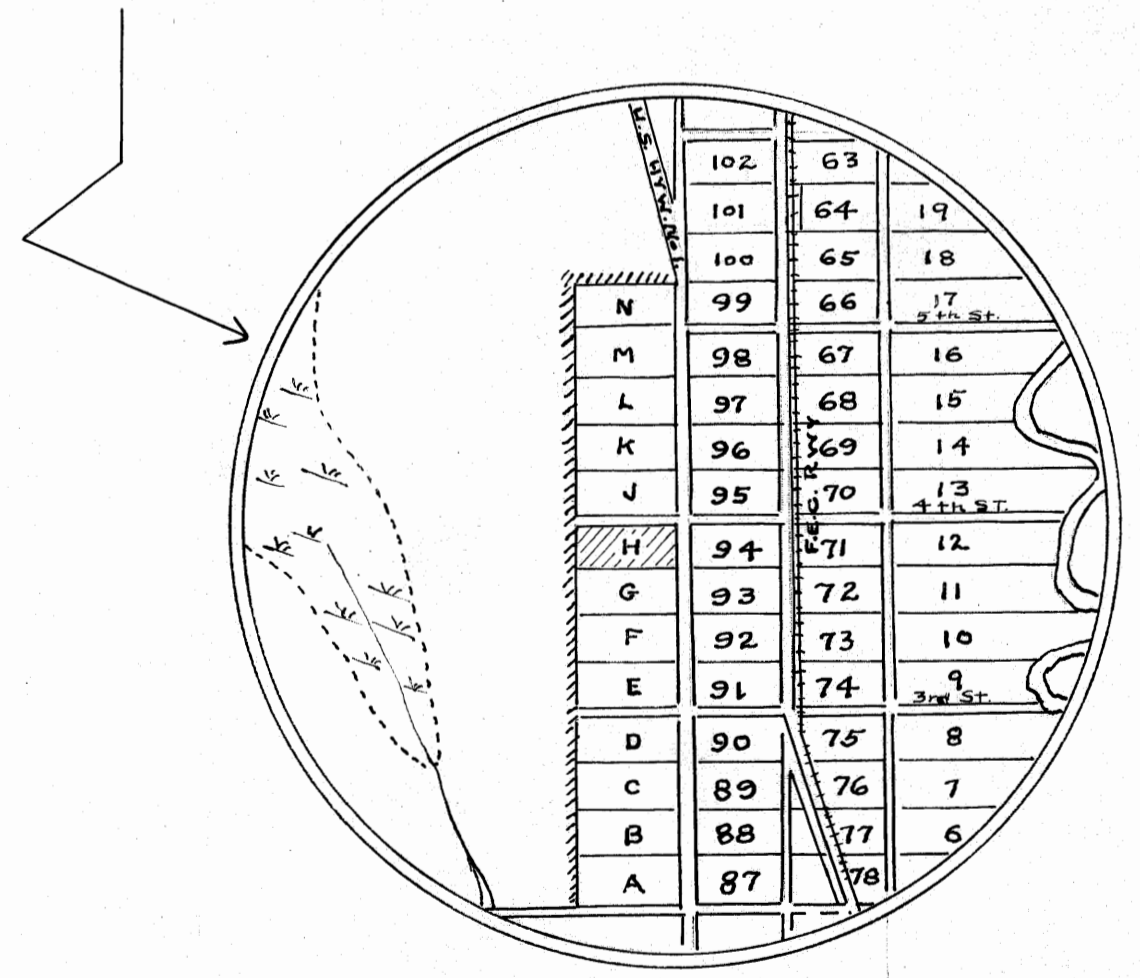
