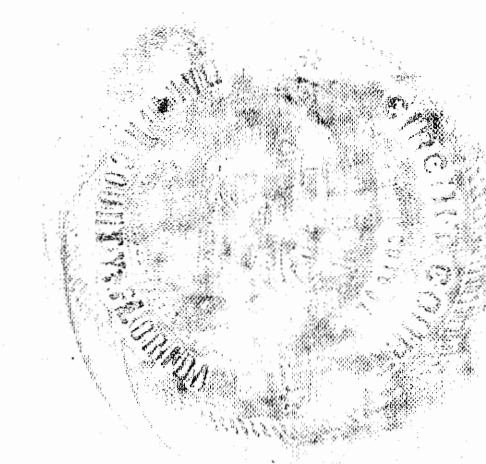


FIRST ADDITION TO ARCH HEIGHTS

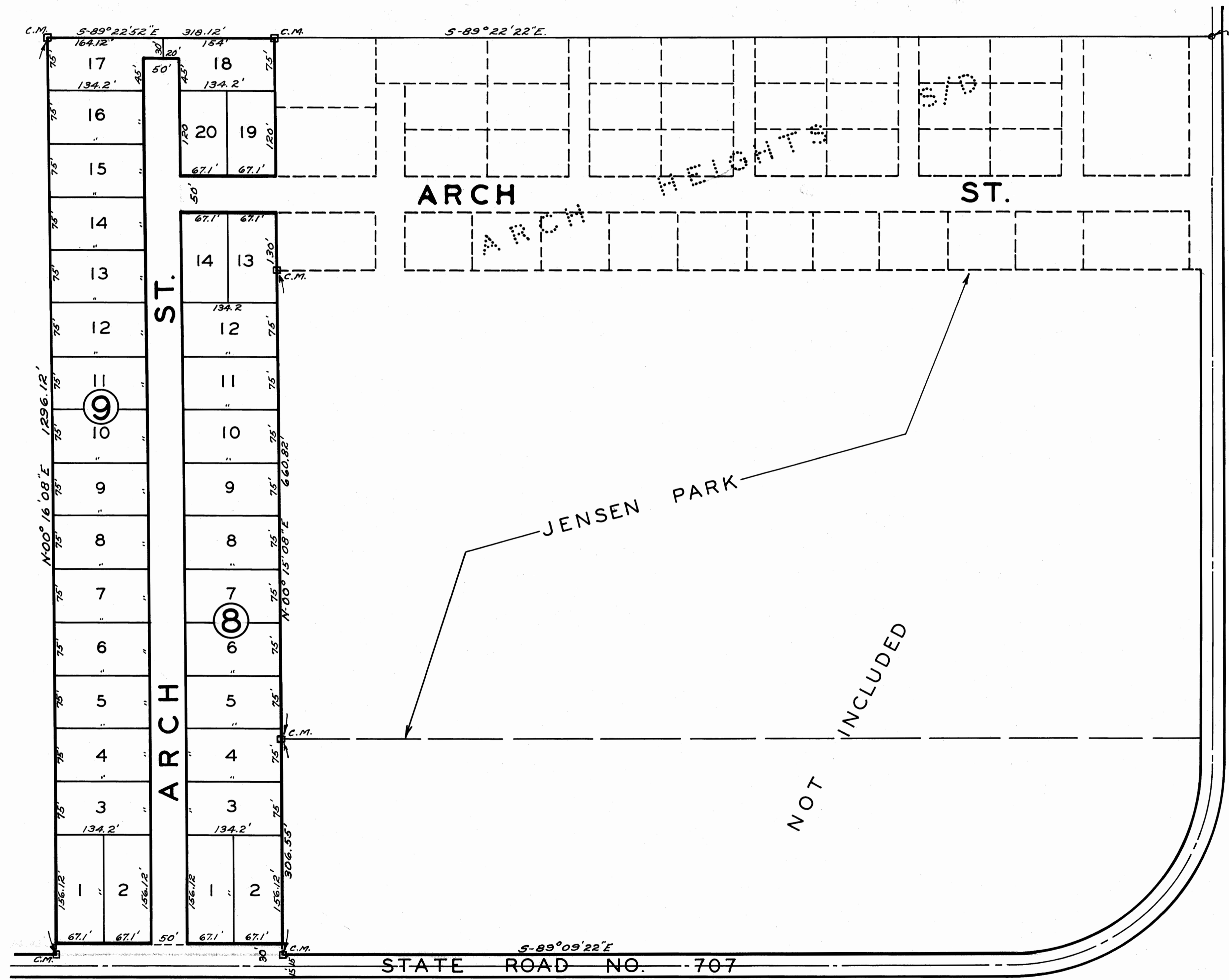
MARTIN COUNTY, FLORIDA.
