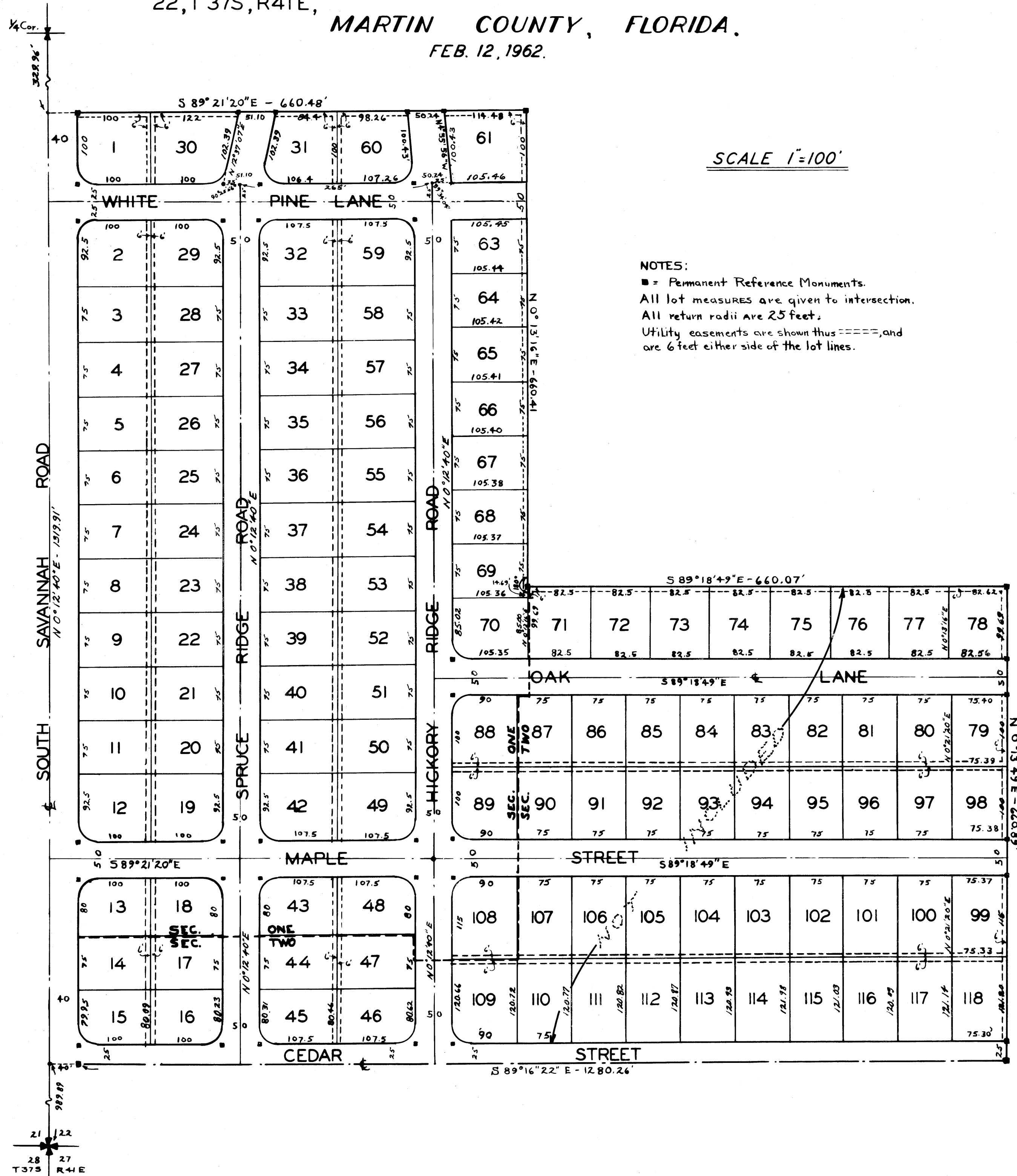


SECTION ONE OF LEGION HEIGHTS
