

Beginning at the Southeast corner of Section 5 thence proceed North 0°40'49" East along the East line of Section 5 for a distance of 723.22 feet to a point on the North right of way line of State Road 726 and the point or place of beginning. (1) Thence proceed South 68°25'32" West along the North right of way line of said State Road for a distance of 82.45 feet to a point of curve to the left or South. (2) Thence proceed Southeasterly along the arc of said curve having a radius of 985 feet through a central angle of 11°25'01" for a distance of 196.27 feet to the point of intersection with the Northerly right of way line of Osceola Boulevard, a county road. (3) Thence proceed North 89°19'44" West along the North right of way line of Osceola Boulevard for a distance of 1073.77 feet to a point on the West line of the East one-half (1/2) of the East one-half (1/2) of Section 5. (4) Thence proceed North 0°42'02" East along the West line of the East one-half (1/2) of Section 5 for a distance of 761.04 feet to a point.
