

MORE PARTICULARLY DESCRIBED AS FOLLOWS: START AT THE SE CORNER OF SECTION I, TOWNSHIP 38 SOUTH, RANGE 40 EAST, THENCE RUN N 89°40'20"W ALONG THE SOUTH LINE OF SECTION I, A DISTANCE OF 2723.48 FEET TO THE POINT OF BEGINNING, SAID POINT OF BEGINNING BEING THE SE CORNER OF THE SE 1/4 OF THE SW 1/4 OF SAID SECTION I. THENCE RUN N 89°38'14"W, A DISTANCE OF 960, 22 FEET TO A P.R.M.; THENCE RUN N 89°40'29"E, A DISTANCE OF 268, 79 FEET TO A P.R.M./P.C.P. ON THE EAST R/W LINE OF WEST MURPHY ROAD; THENCE BY CURVE CONCAVE TO THE SOUTH-EAST, THROUGH A CENTRAL ANGLE OF 04°45'57", RUN NORTHERLY ALONG SAID R/W A DISTANCE OF 39.92 FEET TO A PR.M./P.C.P., THENCE RUN NO5°16'46"E, A DISTANCE OF 535.30 FEET, ALONG SAID R/W TO A PR.M./P.C.P.; THENCE BY CURVE CONCAVE TO THE SOUTHEAST, THROUGH A CENTRAL ANGLE OF 06°55'00", RUN NORTHERLY ALONG SAID R/W A DISTANCE OF 294.81 FEET, ALONG SAID R/W TO A PRM/PCP; THENCE RUN N 12°11'04"E ALONG SAID R/W A DISTANCE OF 440.29 FEET TO P.R.M./P.C.P.; THENCE BY CURVE CONCAVE TO THE SOUTHEAST, THROUGH A CENTRAL ANGLE OF 00°16'07" RUN NORTH-ERLY ALONG SAID EASTERLY R/W, A DISTANCE OF 40.35 FEET TO A P.R.M./P.C.P.; THENCE RUN S 89°31'11"E, A DISTANCE OF 1001.96 FEET TO A P.R.M.; THENCE RUN S 00°03'29"W A DISTANCE OF 1333.23 FEET TO THE POINT OF BEGINNING AND THAT PART OF THE SWI/4 OF THE SEI/4, SECTION I, TOWNSHIP 38 SOUTH, RANGE 40 EAST, LYING NORTH AND WEST OF BESSEY CREEK. 
