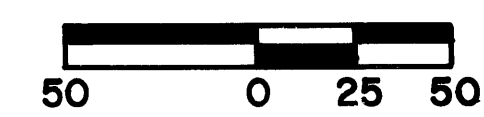
### LEGAL DESCRIPTION

COMMENCING AT THE SOUTHWEST CORNER OF SECTION 9,  
TOWNSHIP 38 SOUTH, RANGE 41 EAST, MARTIN COUNTY, FLORIDA,  
RUN EAST ALONG THE SOUTH LINE OF SAID SECTION A DISTANCE  
OF 310.50 FEET TO THE POINT OR PLACE OF BEGINNING;

- (1) THEN CONTINUE TO RUN EAST ALONG THE SOUTH  
LINE OF SAID SECTION A DISTANCE OF 450.50  
FEET;
- (2) THEN RUN NORTH 19 FEET;
- (3) THEN RUN WEST ALONG A LINE PARALLEL TO THE  
SOUTH LINE OF SAID SECTION FOR A DISTANCE  
OF 450.50 FEET;
- (4) THEN RUN SOUTH 19 FEET TO THE POINT OR  
PLACE OF BEGINNING.

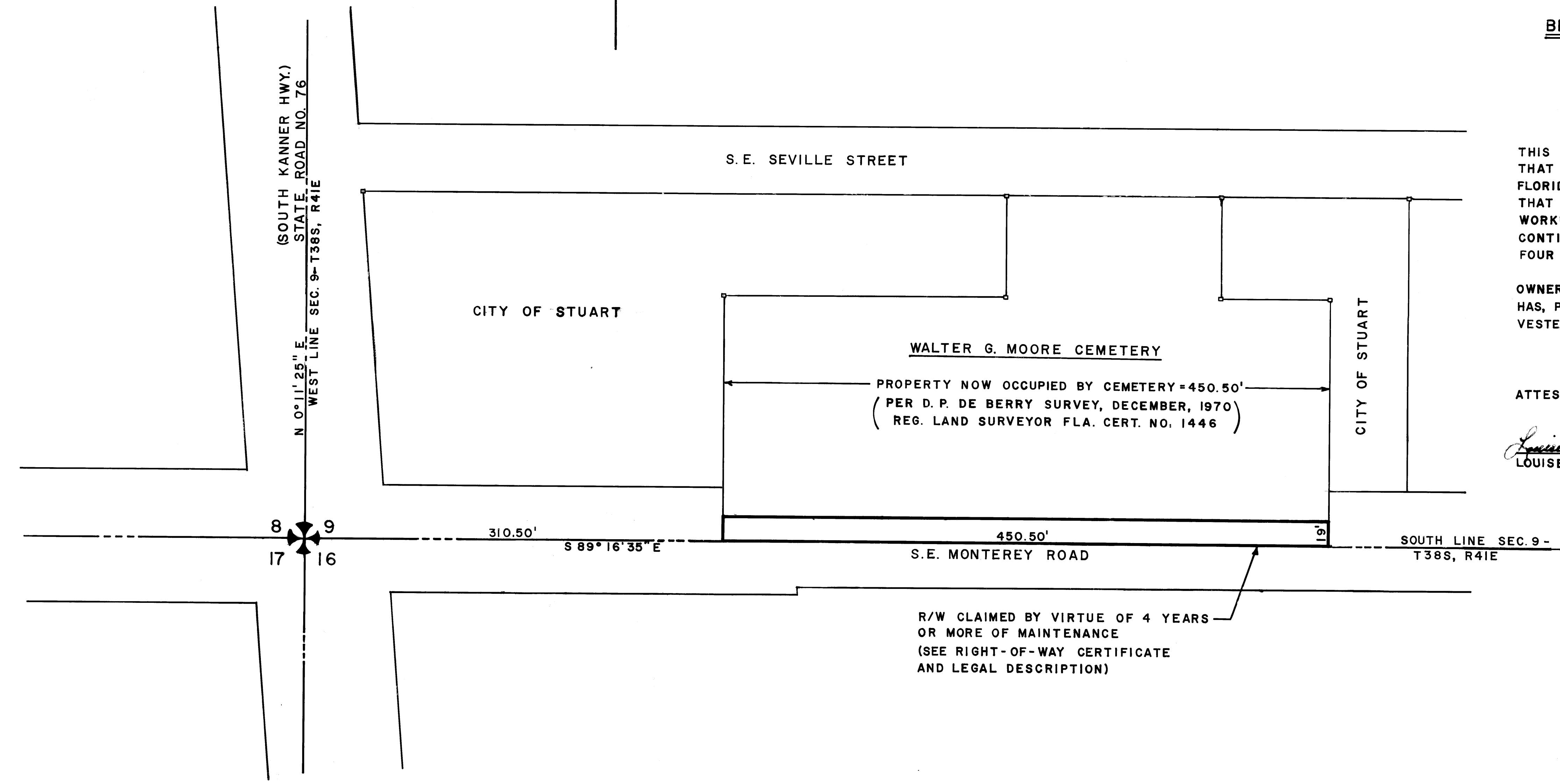
