BEGINNING AT THE NORTHEAST CORNER OF SECTION 8, TOWNSHIP 40 SOUTH, RANGE 39 EAST, MARTIN COUNTY, FLORIDA. THENCE RUN SOUTH 0º18'24" WEST ALONG THE EAST LINE OF SAID SECTION 8 FOR A DISTANCE OF 698.45 FEET TO THE NORTHERLY RIGHT OF WAY LINE OF THE ST. LUCIE CANAL. THENCE RUN SOUTH 68°16'58" WEST ALONG SAID RIGHT OF WAY LINE FOR A DISTANCE OF 230.07 FEET TO THE INTERSECTION WITH THE WESTERLY RIGHT OF WAY OF THE OLD WARFIELD HIGHWAY AND THE POINT OF BEGINNING. 


