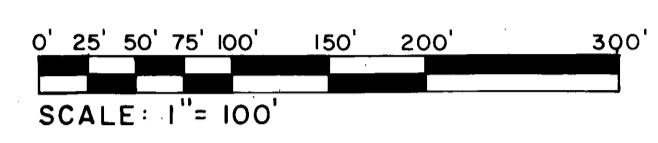


PLAT NO. 5 SAILFISH POINT P.U.D.

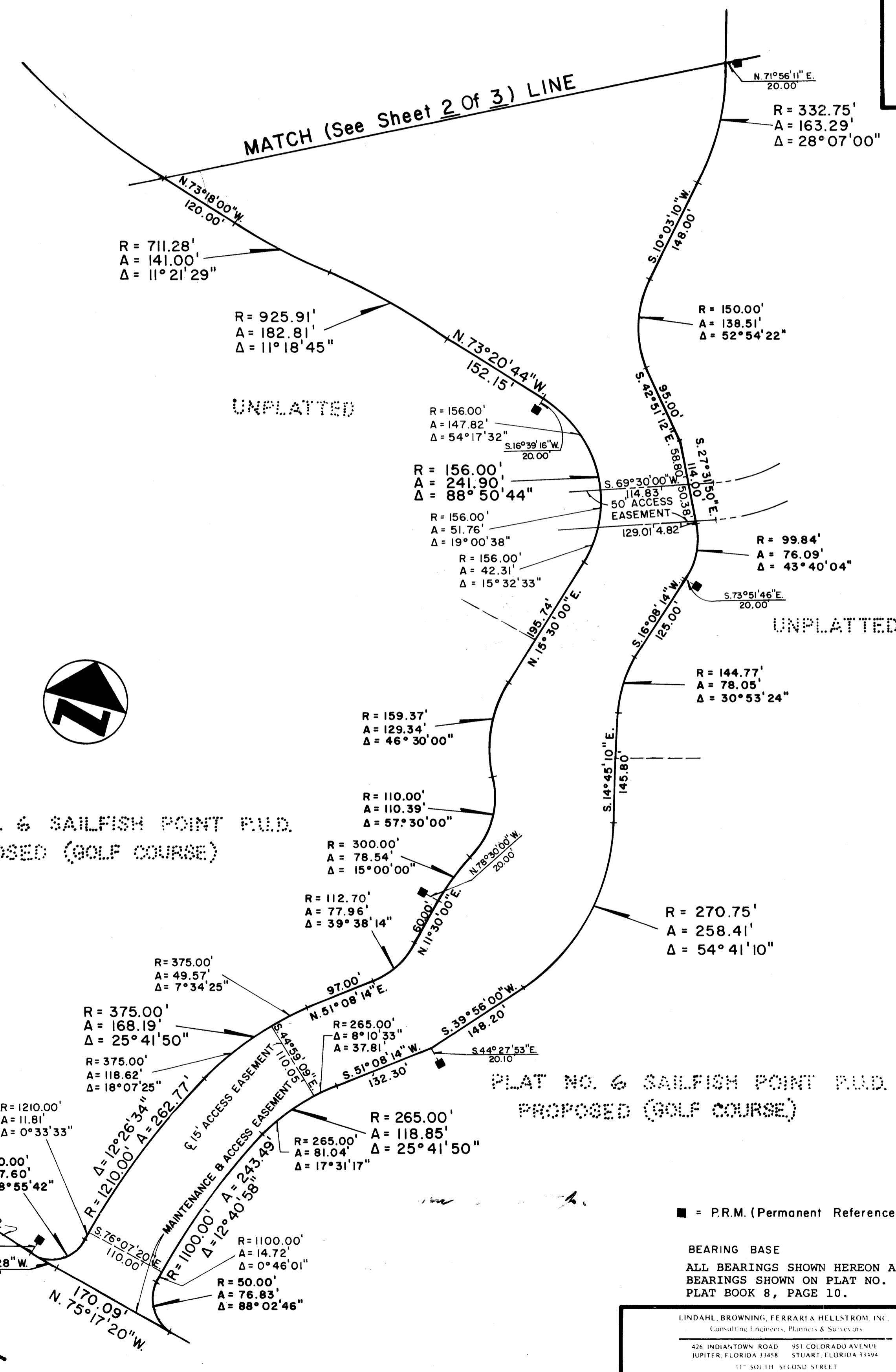

CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 63.71 FEET, THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 91°08'50", A DISTANCE OF 101.35 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 80°16'50" W, A DISTANCE OF 128.87 FEET, THENCE S 89°24'00" W, A DISTANCE OF 127.67 FEET, THENCE N 71°33'54" W, A DISTANCE OF 309.22 FEET, THENCE N 64°08'32" W, A DISTANCE OF 155.50 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 155.35 FEET, THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 57°37'02", A DISTANCE OF 156.22 FEET TO THE POINT OF REVERSE CURVATURE OF A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 116.33 FEET, THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 43°45'06", A DISTANCE OF 88.83 FEET TO THE POINT OF REVERSE CURVATURE OF A CURVE CONCAVE TO THE SOUTH HAVING A RADIUS OF 218.95 FEET, THENCE WESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 31°14'32", A DISTANCE OF 119.39 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE S 70°45'00" W, A DISTANCE OF 156.54 FEET, THENCE S 84°03'46" W, A DISTANCE OF 125.70 FEET, THENCE S 69°22'34" W, A DISTANCE OF 78.53 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 73.06 FEET, THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 83°19'14", A DISTANCE OF 106.24 FEET TO A POINT ON SAID MEAN HIGH WATER LINE, THENCE BY THE FOLLOWING SIX LINES ALONG SAID MEAN HIGH WATER LINE, N 13°56'40" W, A DISTANCE OF 158.18 FEET; THENCE N 03°34'14" W, A DISTANCE OF 100.19 FEET; THENCE N 52°46'58 E, A DISTANCE OF 94.36 FEET; THENCE N 19°12'44" W, A DISTANCE OF 45.46 FEET; THENCE WEST, A DISTANCE OF 78.87 FEET; THENCE N 22°23'56 W, A DISTANCE OF 118.58 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTHEAST HAVING A RADIUS OF 72.98 FEET WHOSE CENTER BEARS N 67°36'04" E, THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 91°34'04", A DISTANCE OF 116.63 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 66°02'00" E, A DISTANCE OF 343.51 FEET, THENCE S 89°36'00" E, A DISTANCE OF 141.31 FEET, THENCE S 34°30'31" E, A DISTANCE OF 57.10 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTHEAST HAVING A RADIUS OF 70.93 FEET, THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 51°24'33", A DISTANCE OF 63.64 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE S 85°55'04" E, A DISTANCE OF 190.77 FEET, THENCE S 64°05'09" E, A DISTANCE OF 107.97 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTH HAVING A RADIUS OF 130.34 FEET, THENCE EASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 40°02'14", A DISTANCE OF 91.08 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 75°52'37" E, A DISTANCE OF 119.15 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 32.66 FEET, THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 64°22'51", A DISTANCE OF 36.70 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 11°29'46" E, A DISTANCE OF 154.00 FEET, THENCE N 18°31'40" W, A DISTANCE OF 120.13 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE EAST HAVING A RADIUS OF 163.52 FEET, THENCE NORTHERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 59°12'40", A DISTANCE OF 168.98 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 40°41'00" E, A DISTANCE OF 56.50 FEET, THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 31°11'36", A DISTANCE OF 116.75 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 9°29'24" E, A DISTANCE OF 178.66 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 342.40 FEET, THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 49°47'27", A DISTANCE OF 297.55 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 59°16'51" E, A DISTANCE OF 186.41 FEET, THENCE N 54°48'45" E, A DISTANCE OF 422.11 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 323.90 FEET, THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 99°37'09", A DISTANCE OF 563.15 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE S 25°34'06" E, A DISTANCE OF 545.82 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 292.30 FEET, THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 40°57'36", A DISTANCE OF 208.96 FEET TO THE POINT OF REVERSE CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 748.37 FEET, THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 5°37'12", A DISTANCE OF 73.41 FEET TO THE POINT OF BEGINNING OF THE HEREIN DESCRIBED PARCEL OF LAND.

FROM THE NORTHEAST CORNER OF SAID FRACTIONAL SECTION 17, BEAR N 88°55'40" W, ALONG THE NORTH LINE OF SAID FRACTIONAL SECTION 17, A DISTANCE OF 1500.75 FEET TO A POINT ON A CURVE CONCAVE TO THE EAST HAVING A RADIUS OF 748.37 FEET WHOSE CENTER BEARS S 80°13'42" E, THENCE SOUTHERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 10°58'45", A DISTANCE OF 143.40 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE S 1°12'27" E, A DISTANCE OF 74.38 FEET, THENCE S 75°17'00" W, A DISTANCE OF 96.03 FEET TO THE POINT OF BEGINNING OF THE HEREIN DESCRIBED PARCEL OF LAND, THENCE S 8°52'30" E, A DISTANCE OF 12.19 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE WEST HAVING A RADIUS OF 1791.10 FEET, THENCE SOUTHERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 4°59'59", A DISTANCE OF 156.29 FEET TO THE POINT OF COMPOUND CURVATURE OF A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 150.00 FEET, THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 101°21'20", A DISTANCE OF 265.35 FEET TO THE POINT OF REVERSE CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST, HAVING A RADIUS OF 118.16 FEET, THENCE NORTHWESTERLY, ALONG THE ARC OF SAID CURVE, THROUGH A CENTRAL ANGLE OF 30°34'04", A DISTANCE OF 63.04 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE S 66°52'20" W, A DISTANCE OF 222.97 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTHEAST HAVING A RADIUS OF 203.71 FEET, THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 44°03'24", A DISTANCE OF 156.64 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 69°04'16" W, A DISTANCE OF 53.90 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE NORTHEAST HAVING A RADIUS OF 122.74 FEET, THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 47°02'26", A DISTANCE OF 100.77 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 22°01'50" W, A DISTANCE OF 69.11 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE EAST HAVING A RADIUS OF 153.01 FEET, THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 81°16'21", A DISTANCE OF 217.05 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 59°14'31" E, A DISTANCE OF 232.97 FEET, THENCE N 51°14'45" E, A DISTANCE OF 150.00 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 282.89 FEET, THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 26°45'43", A DISTANCE OF 132.13 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE N 78°00'28" E, A DISTANCE OF 115.04 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 66.93 FEET, THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 93°07'02", A DISTANCE OF 109.77 FEET TO THE POINT OF TANGENCY OF SAID CURVE, THENCE S 08°52'30" E, A DISTANCE OF 155.26 FEET TO THE POINT OF BEGINNING OF THE HEREIN DESCRIBED PARCEL OF LAND.

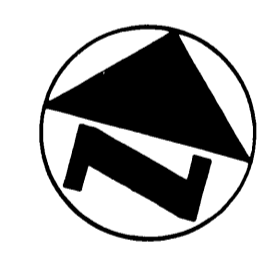
