
WRIGHT'S MINOR PLAT

SECTION 4, TOWNSHIP 39 SOUTH, RANGE 41 EAST

From the Northwest corner of Government Lot 5, Section 4, Township 39 South, Range 41 East, bear South 0°26'55" East along the West line of said Section 4, a distance of 54.52 feet to a point on the South Right of way line of Cove Road; thence North 66°03'05" East along said Right of Way a distance of 58.27 feet to the Point of Beginning (said point being on the East Right of way of Old Gaines Highway); thence, continue North 66°03'05" East, a distance of 1337.93 feet to a point on the North line of Section 4; thence, South 23°56'55" East, a distance of 570.00 feet; thence, South 66°03'05" West, a distance of 1642.52 feet to the Northeast Right of way line of Paulson Road; thence, North 44°51'55" West, along said Right of way line a distance of 19.61 feet to the intersection thereof with the East Right of way line of Old Gaines Highway; thence, North 0°13'45" East along said Right of way line a distance of 349.55 feet; thence, North 0°13'45" East along the Right of way line of Old Gaines Highway; thence, continue North on a bearing of North 12°00'45" East, a distance of 256.78 feet to the Point of Beginning.
